INTRODUCED BY CORMAN, JULY 16, 2009

SENATOR CORMAN, APPROPRIATIONS, RE-REPORTED AS AMENDED, OCTOBER 2, 2009

A SUPPLEMENT

1 To the act of November 30, 1965 (P.L.843, No.355), entitled "An
2 act providing for the establishment and operation of Temple
3 University as an instrumentality of the Commonwealth to serve
4 as a State-related university in the higher education system
5 of the Commonwealth; providing for change of name; providing
6 for the composition of the board of trustees; terms of
7 trustees, and the power and duties of such trustees;
8 providing for preference to Pennsylvania residents in
9 tuition; providing for public support and capital
10 improvements; authorizing appropriations in amounts to be
11 fixed annually by the General Assembly; providing for the
12 auditing of accounts of expenditures from said
13 appropriations; authorizing the issuance of bonds exempt from
14 taxation within the Commonwealth; requiring the President to
15 make an annual report of the operations of Temple
16 University," making appropriations for carrying the same into
17 effect; providing for a basis for payments of such
18 appropriations; and providing a method of accounting for the
19 funds appropriated and for certain fiscal information
20 disclosure.

21 The General Assembly of the Commonwealth of Pennsylvania
22 hereby enacts as follows:

23 Section 1. (a) The following sum, or as much thereof as may
24 be necessary, is hereby appropriated to the Trustees of Temple
25 University for the fiscal year July 1, 2009, to June 30, 2010,
26 for the purposes and in the amount as shown:

27 For general support.....\$164,974,000

1 (b) The following Federal amount is hereby appropriated to
2 the Trustees of Temple University in order to supplement the sum
3 appropriated under subsection (a):

4	"ARRA - FISCAL STABILIZATION - general support."	←

7 (c) The following Federal amount, or as much thereof as may
8 be necessary, is hereby appropriated to the Trustees of Temple
9 University for the fiscal year July 1, 2008, to June 30, 2009,
10 for the purpose and in the amount as shown, including the
11 payment of bills remaining unpaid at the close of the fiscal
12 year ending June 30, 2009:

13	"ARRA - FISCAL STABILIZATION - general support."	←

16 (d) For purposes of this section, "ARRA" means the American
17 Recovery and Reinvestment Act of 2009 (Public Law 111-5, 123
18 Stat. 115).

19 Section 2. Payments to Temple University on account of the
20 appropriations for all items as provided in section 1 shall be
21 made on the basis of costs during the fiscal year.

22 Section 3. (a) Payment to Temple University of the
23 appropriations provided in section 1(a) and (b) shall be made
24 monthly during the fiscal year and the appropriation provided in
25 section 1(c) shall be made no later than ~~September 15, 2009~~ 30 ←
26 DAYS FROM THE COMMONWEALTH'S RECEIPT OF FUNDS UNDER THE ARRA
27 STATE FISCAL STABILIZATION FUND PROGRAM.

28 (b) Such monthly payments shall be made in accordance with
29 the provisions of section 2 on the basis of estimated costs. The
30 estimate of costs shall be submitted by Temple University to the

1 Secretary of Education, the General Assembly and the State
2 Treasurer not later than 30 days prior to the date on which such
3 payment is to be made.

4 Section 4. (a) Temple University shall apply the moneys
5 appropriated by this act only for such purposes as are permitted
6 in this act and shall at all times maintain proper records
7 showing the application of such moneys. Not later than 120 days
8 after the close of the fiscal year to which this act relates,
9 Temple University shall file, with the Secretary of Education,
10 the General Assembly and the Auditor General of the
11 Commonwealth, a statement setting forth the amounts and purposes
12 of all expenditures made from moneys appropriated by this act
13 and other university accounts during said fiscal year, as
14 provided in section 2, used as a basis for receipt of any
15 appropriation during said fiscal year.

16 (b) Such statement of expenditures and costs shall be
17 reviewed by the Auditor General of the Commonwealth, and he
18 shall have the right, in respect to the moneys appropriated by
19 this act, to audit and disallow expenditures made for purposes
20 not permitted by this act and to cause such sums to be recovered
21 and paid by Temple University to the State Treasurer. In respect
22 to expenditures made by the university from moneys other than
23 those appropriated by this act, the Auditor General shall have
24 the right to review only, and he shall file annually with the
25 General Assembly such information concerning said expenditures
26 as the General Assembly or any of its committees may require.

27 Section 5. Temple University shall provide full, complete
28 and accurate information as may be required by the Department of
29 Education or the chairman or the minority chairman of the
30 Appropriations Committee of the Senate or the chairman or the

1 minority chairman of the Appropriations Committee of the House
2 of Representatives.

3 Section 6. Temple University shall present and report its
4 financial statements required under the provisions of this act
5 in accordance with: the generally accepted accounting principles
6 as prescribed by the National Association of College and
7 University Business Officers, the American Institute of
8 Certified Public Accountants, or their successors, or by any
9 other recognized authoritative body; the "Commonwealth of
10 Pennsylvania Budget Instructions for the State System of Higher
11 Education, State-Related Universities and Non-State-Related
12 Colleges and Universities"; and the financial reporting policies
13 and standards promulgated by the Commonwealth of Pennsylvania
14 and by the Federal Government that apply to Temple University.

18 Section 8 7. This act shall take effect immediately. ←
