AN ACT

- 1 Making an appropriation to the Trustees of the University of 2 Pennsylvania.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The sum of \$35,682,000 \$34,419,000, or as much
- 6 thereof as may be necessary, is hereby appropriated to the
- 7 Trustees of the University of Pennsylvania for the fiscal year
- 8 July 1, 2009, to June 30, 2010, for veterinary activities.
- 9 Section 2. (a) Payments to the University of Pennsylvania
- 10 on account of the appropriation shall be made quarterly by the
- 11 Secretary of Education on the basis of costs during the fiscal
- 12 year and shall be conditioned on continuing authority for
- 13 inclusion on the Board of Trustees of the University of
- 14 Pennsylvania of a minimum of four persons who are not elected
- 15 officials and who are appointed by the President pro tempore of
- 16 the Senate, the Minority Leader of the Senate, the Speaker of
- 17 the House of Representatives and the Minority Leader of the
- 18 House of Representatives for terms of office coterminous with

- 1 that of the respective appointing authority; and shall be
- 2 further conditioned on these appointees receiving full voting
- 3 rights as members of the board of trustees.
- 4 (b) The University of Pennsylvania shall provide full,
- 5 complete and accurate information as may be required by the
- 6 Department of Education or the chairman or the minority chairman
- 7 of the Appropriations Committee of the Senate or the chairman or
- 8 the minority chairman of the Appropriations Committee of the
- 9 House of Representatives.
- 10 (c) The University of Pennsylvania shall report its revenues
- 11 and expenditures and present its financial statements in
- 12 accordance with generally accepted accounting principles and
- 13 procedures for educational institutions as set forth in the
- 14 "Higher Education Finance Manual (1975)" and the "Commonwealth
- 15 of Pennsylvania Budget Instructions for the State System of
- 16 Higher Education, State-Related Universities and Non-State-
- 17 Related Colleges and Universities."
- 18 (d) The Trustees of the University of Pennsylvania shall
- 19 report on forms provided by the Department of Education to both
- 20 the chairman and minority chairman of the Appropriations
- 21 Committee of the Senate and the chairman and minority chairman
- 22 of the Appropriations Committee of the House of Representatives
- 23 by September 30, 2010, on how State-appropriated funds were
- 24 expended for fiscal year 2009-2010 to reduce the costs to
- 25 Pennsylvania resident students or to provide services to
- 26 Pennsylvania residents.
- 27 Section 3. This act shall take effect immediately.
