AN ACT

- 1 Making an appropriation to the Trustees of Drexel University, 2 Philadelphia.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The sum of \$1,563,000 is hereby appropriated to
- 6 the Trustees of Drexel University, Philadelphia, for the fiscal
- 7 year July 1, 2009, to June 30, 2010, for instruction and student
- 8 aid.
- 9 Section 2. Payments to Drexel University on account of the
- 10 appropriation provided in section 1 shall be made quarterly by
- 11 the Secretary of Education on the basis of costs during the
- 12 fiscal year and shall be conditioned on continuing authority for
- 13 inclusion on the Board of Trustees of Drexel University of a
- 14 minimum of five persons who are not elected officials and who
- 15 are appointed by the Governor, the President pro tempore of the
- 16 Senate, the Minority Leader of the Senate, the Speaker of the
- 17 House of Representatives and the Minority Leader of the House of
- 18 Representatives for terms of office coterminous with that of the

- 1 respective appointing authority.
- 2 Section 3. The Drexel University shall provide full,
- 3 complete and accurate information as may be required by the
- 4 Department of Education or the chairman or the minority chairman
- 5 of the Appropriations Committee of the Senate or the chairman or
- 6 the minority chairman of the Appropriations Committee of the
- 7 House of Representatives.
- 8 Section 4. Drexel University shall report its revenues and
- 9 expenditures and present its financial statements in accordance
- 10 with generally accepted accounting principles and procedures for
- 11 educational institutions as set forth in the "Higher Education
- 12 Finance Manual (1975)" and the "Commonwealth of Pennsylvania
- 13 Budget Instructions for the State System of Higher Education,
- 14 State-Related Universities and Non-State-Related Colleges and
- 15 Universities."
- 16 Section 5. The Trustees of Drexel University shall report on
- 17 forms provided by the Department of Education to the chairman
- 18 and the minority chairman of the Appropriations Committee of the
- 19 Senate and the chairman and minority chairman of the
- 20 Appropriations Committee of the House of Representatives by
- 21 September 30, 2010, on how State-appropriated funds were
- 22 expended for fiscal year 2009-2010 to reduce the costs to
- 23 Pennsylvania resident students or to provide services to
- 24 Pennsylvania residents.
- 25 Section 6. This act shall take effect immediately.
