## AN ACT

- 1 Designating State Route 283, from the PA Turnpike Interchange in
- Lower Swatara Township, Dauphin County, to State Route 30 in
- Manheim Township, Lancaster County, as the 283rd Field
- 4 Artillery Battalion Highway.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The 283rd Field Artillery Battalion Highway.
- 8 (a) Findings.--
- 9 (1) The soldiers of the United States Army's 283rd Field
- 10 Artillery Battalion served with valor and distinction in
- 11 combat in the European Theater of Operations in World War II.
- 12 The battalion was in combat for 268 continuous days and
- traveled a total distance of approximately 10,757 miles over
- land and sea during active service.
- 15 (2) The 283rd Field Artillery Battalion was activated at
- 16 Camp Rucker, Alabama, on June 25, 1943. After a year of
- 17 stateside training, the Battalion sailed to the United
- 18 Kingdom on June 22, 1944, where training continued at Camp

- 1 Llanover, Wales, before cross-channel deployment.
- 2 (3) The 283rd Field Artillery Battalion was part of the
- 3 historic landing at Utah Beach on August 11, 1944. The
- 4 battalion fought through France to Berchtesgaden, Germany,
- 5 during the Campaign for Northern France from August 11 to
- 6 September 14, 1944.
- 7 (4) The 283rd continued combat in the Campaign for the
- 8 Rhineland from September 15, 1944, to March 22, 1945, and in
- 9 the Campaign for Central Europe from March 23, 1945 to May 8,
- 10 1945 (VE Day).
- 11 (5) During the final campaign, the 283rd Field Artillery
- 12 Battalion took part in the Battle of Bamberg, the Battle of
- Nurnberg and the Battle of Munich.
- 14 (6) Not organic to any specific division, the 283rd
- 15 Field Artillery Battalion served under various headquarters
- of Armies, Corps, Groups and Divisions.
- 17 (b) Designation.--State Route 283, from the PA Turnpike
- 18 Interchange in Lower Swatara Township, Dauphin County, to State
- 19 Route 30 in Manheim Township, Lancaster County, is designated as
- 20 the 283rd Field Artillery Battalion Highway.
- 21 (c) Signs.--The Department of Transportation shall erect and
- 22 maintain appropriate signs displaying the name of the highway to
- 23 traffic in both directions.
- 24 Section 2. Effective date.
- This act shall take effect in 60 days.
