AN ACT

1 Designating State Route 462 from its intersection with U.S.
 2 Route 30 in West Manchester Township, York County, to the
 3 point where it meets State Route 24 in Springettsbury
 4 Township, York County, as the Korean War Veterans Memorial
 5 Highway.

6 The General Assembly of the Commonwealth of Pennsylvania
 7 hereby enacts as follows:

8 Section 1. Korean War Veterans Memorial Highway.

9 (a) Findings.--The General Assembly finds and declares as
 10 follows:

11 (1) The Korean War was waged from June of 1950 to July
 12 of 1953 and ended with a negotiated armistice. Officially,
 13 the United States' presence in Korea was a police action.

14 (2) One million five hundred thousand Americans served
 15 in the Korean War. Nearly 37,000 Americans died in the

1 conflict and 103,000 others were wounded. Approximately 8,000
2 Americans are still listed as missing in action.

3 (b) Designation.--State Route 462 from its intersection with
4 U.S. Route 30 in West Manchester Township, York County, to the
5 point where it meets State Route 24 in Springettsbury Township,
6 York County, is designated as the Korean War Veterans Memorial
7 Highway.

8 (c) Signs.--The Department of Transportation shall erect and
9 maintain appropriate signs displaying the name of the highway to
10 traffic in both directions.

11 Section 2. Effective date.

12 This act shall take effect in 60 days.
