## AN ACT

- Amending the act of May 22, 1951 (P.L.317, No.69), entitled, as amended, "An act relating to the practice of professional
- nursing; providing for the licensing of nurses and for the
- 4 revocation and suspension of such licenses, subject to
- appeal, and for their reinstatement; providing for the
- 6 renewal of such licenses; regulating nursing in general;
- 7 prescribing penalties and repealing certain laws," further
- 8 providing for use of title.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:

- 1 Section 1. Section 3 of the act of May 22, 1951 (P.L.317,
- 2 No.69), known as The Professional Nursing Law, amended July 20,
- 3 2007 (P.L.320, No.49), is amended to read:
- 4 Section 3. Registered Nurse, Clinical Nurse Specialist, Use
- 5 of Title and Abbreviation "R.N." or "C.N.S."; Credentials;
- 6 Fraud.--(a) Any person who holds a license to practice
- 7 professional nursing in this Commonwealth, or who is maintained
- 8 on inactive status in accordance with section 11 of this act,
- 9 shall have the right to use the [title] <u>titles "nurse" and</u>
- 10 "registered nurse" and the abbreviation "R.N." No other person
- 11 shall engage in the practice of professional nursing or use the
- 12 [title] <u>titles "nurse" or</u> "registered nurse" or the abbreviation
- 13 "R.N." to indicate that the person using the same is a
- 14 registered nurse[.], except that the title "nurse" also may be
- 15 used by a person licensed under the provisions of the act of
- 16 March 2, 1956 (1955 P.L.1211, No.376), known as the "Practical"
- 17 <u>Nurse Law."</u> No person shall sell or fraudulently obtain or
- 18 fraudulently furnish any nursing diploma, license, record, or
- 19 registration or aid or abet therein.
- 20 (b) An individual who holds a license to practice
- 21 professional nursing in this Commonwealth who meets the
- 22 requirements under sections 6.2 and 8.5 of this act to be a
- 23 clinical nurse specialist shall have the right to use the title
- 24 "clinical nurse specialist" and the abbreviation "C.N.S." No
- 25 other person shall have that right.
- 26 (C) NOTWITHSTANDING SUBSECTION (A), THIS SECTION SHALL NOT
- 27 PROHIBIT THE USE BY A PERSON OF A DESCRIPTIVE TITLE FOR NURSE
- 28 ASSISTIVE PERSONNEL. FOR THE PURPOSES OF THIS SUBSECTION, THE
- 29 TERM "NURSE ASSISTIVE PERSONNEL" SHALL MEAN AN INDIVIDUAL
- 30 PROVIDING HEALTH CARE SERVICES UNDER THE SUPERVISION OF A

- 1 PROFESSIONAL OR PRACTICAL NURSE.
- 2 Section 2. This act shall take effect in 60 days.
