AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, requiring compliance with Federal Selective Service
- requirements as part of application for learners' permits or
- 4 drivers' licenses.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 75 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 1521. Compliance with Federal Selective Service requirements.
- 10 (a) General rule. -- Any United States citizen or immigrant
- 11 who applies for a learner's permit, identification card or
- 12 driver's license or a renewal of such permit, card or license
- 13 and who is at least 18 years of age, but less than 26 years of
- 14 age, must comply with the requirements of section 3 of the
- 15 Military Selective Service Act (62 Stat. 604, 50 U.S.C. App. §
- 16 451 et seq.).
- 17 <u>(b) Effect of applicant's signature.--The applicant's</u>
- 18 signature on the application shall serve as an indication that

- 1 the applicant either has already registered with the Selective
- 2 <u>Service System or consents to registration if required to</u>
- 3 consent unless the applicant affirmatively indicates lack of
- 4 consent by checking the box provided on the application.
- 5 (c) Notification to applicant. -- The department shall place a
- 6 <u>check-off box as required under subsection (b) and the following</u>
- 7 <u>statement on the application:</u>
- 8 By signing this application you are consenting to
- 9 <u>registration with the Selective Service System, if so</u>
- 10 required by Federal law, unless you affirmatively
- indicate your lack of consent by placing a check mark in
- the box provided herein. Failure to register, if required
- to do so, is a felony.
- 14 (d) Failure to consent. -- If the applicant declines to
- 15 consent to registration with the Selective Service System, the
- 16 department shall not deny the applicant a license or
- 17 identification card for failure to consent to registration.
- 18 <u>(e)</u> Reporting of information.--
- 19 (1) The department shall forward, in electronic format
- 20 to the Selective Service System, the necessary personal
- 21 <u>information of the applicants required to comply with the</u>
- 22 Military Selective Service Act. If the applicant fails to
- 23 <u>consent to registration, the department shall forward, in</u>
- 24 electronic format to the Selective Service System, the
- 25 <u>necessary personal information along with a notation that</u>
- 26 <u>registration was declined.</u>
- 27 (2) Within 60 days of forwarding the information to the
- 28 Selective Service System under paragraph (1), the department
- 29 shall notify the applicant in writing that the information
- 30 has been so forwarded.

- 1 (f) Memorandum of understanding. -- The department shall seek
- 2 to enter into a memorandum of understanding with the Selective
- 3 Service System to obtain reimbursement of costs incurred by the
- 4 <u>department in carrying out the provisions of this section. The</u>
- 5 <u>department shall publish in the Pennsylvania Bulletin notice of</u>
- 6 the execution of the memorandum of understanding within 14 days
- 7 of its execution.
- 8 Section 2. The addition of 75 Pa.C.S. § 1521 shall apply
- 9 upon publication of the notice under 75 Pa.C.S. § 1521(f).
- 10 Section 3. This act shall take effect in 60 days.
