AN ACT

Amending the act of August 15, 1961 (P.L.987, No.442), entitled "An act relating to public works contracts; providing for prevailing wages; imposing duties upon the Secretary of Labor 3 and Industry; providing remedies, penalties and repealing existing laws," further providing for definitions; and 5 providing for school district options. 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 Section 1. Section 2(4) of the act of August 15, 1961 (P.L. 10 987, No.442), known as the Pennsylvania Prevailing Wage Act, is 11 amended to read: 12 Section 2. Definitions. -- As used in this act--13 14 "Public body" means [the] any of the following: (4)(i) The Commonwealth [of Pennsylvania, any of its]. 15 16 (ii) A political [subdivisions, any] subdivision. Except as

set forth in section 13.1, this subparagraph does not include a

- 8 Section 2. The act is amended by adding a section to read:
- 9 Section 13.1. School District Option. -- Notwithstanding any
- 10 provision of this act, a school district or an authority, agency
- 11 or instrumentality established by one or more school districts
- 12 may elect, by resolution, to be a public body and to subject
- 13 itself to this act.
- 14 Section 3. All acts and parts of acts are repealed insofar
- 15 as they are inconsistent with this act.
- 16 Section 4. This act shall take effect in 60 days.
