AN ACT

Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as reenacted, "An act relating to alcoholic liquors, alcohol and 2 malt and brewed beverages; amending, revising, consolidating 3 and changing the laws relating thereto; regulating and 4 restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding in bond, holding in storage, traffic in and use of alcoholic 7 liquors, alcohol and malt and brewed beverages and the 8 persons engaged or employed therein; defining the powers and 9 duties of the Pennsylvania Liquor Control Board; providing 10 for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," 17 further providing for definitions and for unlawful acts relative to malt or brewed beverages and licensees. 18 19 The General Assembly of the Commonwealth of Pennsylvania 20 hereby enacts as follows: 21 Section 1. Section 102 of the act of April 12, 1951 (P.L.90, No.21), known as the Liquor Code, reenacted and amended June 29, 22 23 1987 (P.L.32, No.14), is amended by adding a definition to read: 24 Section 102. Definitions .-- The following words or phrases, 25 unless the context clearly indicates otherwise, shall have the

meanings ascribed to them in this section:

- 13 (22) Caffeinated or Stimulant-enhanced Malt Beverages. No
- 14 person shall import into this Commonwealth or distribute, sell
- 15 or offer to sell in this Commonwealth any caffeinated or
- 16 <u>stimulant-enhanced malt beverage.</u>
- 17 Section 3. This act shall take effect in 60 days.
