AN ACT

1 Amending the act of July 6, 2010 (P.L. , No.1A), entitled "An  
 2 act to provide from the General Fund for the expenses of the  
 3 Executive, Legislative and Judicial Departments of the  
 4 Commonwealth, the public debt and the public schools for the  
 5 fiscal year July 1, 2010, to June 30, 2011, for certain  
 6 institutions and organizations, and for the payment of bills  
 7 incurred and remaining unpaid at the close of the fiscal year  
 8 ending June 30, 2010; to provide appropriations from the  
 9 State Lottery Fund, the Energy Conservation and Assistance  
 10 Fund, the Aviation Restricted Revenue Account, the Hazardous  
 11 Material Response Fund, The State Stores Fund, the Milk  
 12 Marketing Fund, the Home Investment Trust Fund, the Emergency  
 13 Medical Services Operating Fund, the Tuition Payment Fund,  
 14 the Banking Department Fund, the Firearm Records Check Fund,  
 15 the Ben Franklin Technology Development Authority Fund and  
 16 the Tobacco Settlement Fund to the Executive Department; to  
 17 provide appropriations from the Judicial Computer System  
 18 Augmentation Account to the Judicial Department for the  
 19 fiscal year July 1, 2010, to June 30, 2011; to provide  
 20 appropriations from the Motor License Fund for the fiscal  
 21 year July 1, 2010, to June 30, 2011, for the proper operation  
 22 of the several departments of the Commonwealth and the  
 23 Pennsylvania State Police authorized to spend Motor License  
 24 Fund moneys; to provide for the appropriation of Federal  
 25 funds to the Executive Department of the Commonwealth and for  
 26 the payment of bills remaining unpaid at the close of the  
 27 fiscal year ending June 30, 2010; and to provide for the  
 28 additional appropriation of Federal and State funds from the  
 29 General Fund and the State Lottery Fund for the Executive  
 30 Department of the Commonwealth for the fiscal year July 1,  
 31 2009, to June 30, 2010, and for the payment of bills incurred  
 32 and remaining unpaid at the close of the fiscal year ending

1 June 30, 2009," by further providing for the appropriation of  
2 Federal funds and reducing the State appropriation to the  
3 Department of Education for basic education.

4 The General Assembly of the Commonwealth of Pennsylvania  
5 hereby enacts as follows:

6 Section 1. As much as relates to the Federal and State  
7 appropriations for basic education in section 212 of the act of  
8 July 6, 2010 (P.L. , No.1A), known as the General  
9 Appropriation Act of 2010, are amended to read:

10 Section 212. Department of  
11 Education.--The following amounts  
12 are appropriated to the Department  
13 of Education:

19 The following Federal amounts are  
20 appropriated to supplement the sum  
21 appropriated for Basic Education  
22 Funding:

23 (1) "ARRA - Fiscal Stabilization		
24 - Basic Education."		
25 Federal appropriation.....	654,747,000	
26 <u>(2) "Education Jobs Fund."</u>		
27 <u>Federal appropriation.....</u>	<u>387,816,000</u>	

28 Payments to each school district  
29 shall be from [both] the Federal  
30 appropriation for "ARRA - Fiscal  
31 Stabilization - Basic Education" and

1 the "Education Jobs Fund" and the  
2 State appropriation for payment of  
3 basic education funding to school  
4 districts in proportion to each  
5 appropriation's share of the total  
6 allocation for basic education  
7 funding.
