A JOINT RESOLUTION

- 1 Proposing integrated amendments to the Constitution of the
- Commonwealth of Pennsylvania, further providing for terms of
- members and for the Legislative Reapportionment Commission.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following integrated amendments to the
- 7 Constitution of Pennsylvania are proposed in accordance with
- 8 Article XI:
- 9 (1) That section 3 of Article II be amended to read:
- 10 § 3. Terms of members.
- 11 [Senators shall be elected for the term of four years and
- 12 Representatives for the term of two years.]
- 13 (a) Senators shall be elected for the term of six years. No
- 14 person shall hold the office of Senator for a period of longer
- 15 than two successive terms of six years. Terms of Senators shall
- 16 be considered successive unless separated by a period of six or
- 17 more years. Representatives shall be elected for the term of
- 18 four years. No person shall hold the office of Representative

- 1 for a period longer than three successive terms of four years.
- 2 Terms of Representatives shall be considered successive unless
- 3 separated by a period of four or more years.
- 4 (b) In determining the eligibility of an individual to hold
- 5 office in accordance with subsection (a):
- 6 (1) Time spent in office in fulfillment of a term to which
- 7 <u>another person was first elected shall not be considered</u>,
- 8 provided that a period of at least six years for Senators and at
- 9 <u>least four years for Representatives passed between the time, if</u>
- 10 any, the individual previously held that office and the time the
- 11 individual is elected to fulfill the unexpired term.
- 12 (2) A person who is elected to office in a regularly
- 13 scheduled general election and resigns prior to the completion
- 14 of the term for which the person was elected shall be considered
- 15 to have served the full term in that office.
- 16 (c) Senators in even-numbered districts elected at the
- 17 general election in 2012 shall serve a six-year term. Senators
- 18 in odd-numbered districts elected at the general election in
- 19 2012 shall serve a six-year term. Senators now elected and those
- 20 whose terms are unexpired shall represent the districts in which
- 21 they reside until the end of the terms for which they were
- 22 elected.
- 23 (d) Representatives in odd-numbered districts elected at the
- 24 general election in 2012 shall serve a four-year term, and
- 25 Representatives in even-numbered districts elected at the
- 26 general election in 2012 shall serve a two-year term.
- 27 Representatives in even-numbered districts elected at the
- 28 general election in 2014 shall serve a four-year term.
- 29 (2) That section 17(f) of Article II be amended to read:
- 30 § 17. Legislative Reapportionment Commission.

- 2 (f) Any district which does not include the residence from
- 3 which a member of the Senate or House of Representatives was
- 4 elected whether or not scheduled for election at the next
- 5 general election shall elect a Senator or Representative at such
- 6 election.
- 7 * * *
- 8 Section 2. The provisions of this resolution apply only to
- 9 terms served by members of the General Assembly after the first
- 10 election cycle following the ratification of this constitutional
- 11 amendment and thereafter.
- 12 Section 3. (a) Upon the first passage by the General
- 13 Assembly of these proposed constitutional amendments, the
- 14 Secretary of the Commonwealth shall proceed immediately to
- 15 comply with the advertising requirements of section 1 of Article
- 16 XI of the Constitution of Pennsylvania and shall transmit the
- 17 required advertisements to two newspapers in every county in
- 18 which such newspapers are published in sufficient time after
- 19 passage of these proposed constitutional amendments.
- 20 (b) Upon the second passage by the General Assembly of these
- 21 proposed constitutional amendments, the Secretary of the
- 22 Commonwealth shall proceed immediately to comply with the
- 23 advertising requirements of section 1 of Article XI of the
- 24 Constitution of Pennsylvania and shall transmit the required
- 25 advertisements to two newspapers in every county in which such
- 26 newspapers are published in sufficient time after passage of
- 27 these proposed constitutional amendments. The Secretary of the
- 28 Commonwealth shall submit the proposed constitutional amendments
- 29 under section 1 to the qualified electors of this Commonwealth
- 30 as a single ballot question at the first primary, general or

- 1 municipal election which meets the requirements of and is in
- 2 conformance with section 1 of Article XI of the Constitution of
- 3 Pennsylvania and which occurs at least three months after the
- 4 proposed constitutional amendments are passed by the General
- 5 Assembly.
