AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, providing for a special license plate for
3 recipients of the Silver Star, Bronze Star and Bronze Star
4 for Valor AND FOR SPECIAL PLATES FOR RECIPIENTS OF
5 DISTINGUISHED SERVICE CROSS, DISTINGUISHED FLYING CROSS, NAVY
6 CROSS OR AIR FORCE CROSS. ←

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. Title 75 of the Pennsylvania Consolidated
10 Statutes is amended by adding sections to read:

11 § 1366. Special plates for recipients of Silver Star.

12 Upon application of any person who is a recipient of the
13 Silver Star, accompanied by a fee of \$10 which shall be in
14 addition to the annual registration fee and by such

1 documentation as the department shall require, the department
2 shall issue to the person a special registration plate
3 designating the vehicle so licensed as belonging to a person who
4 is a recipient of the Silver Star. The special registration
5 plate may be used only on a passenger car or truck with a
6 registered gross weight of not more than 14,000 pounds.

7 § 1367. Special plates for recipients of Bronze Star.

8 Upon application of any person who is a recipient of the
9 Bronze Star, accompanied by a fee of \$20 which shall be in
10 addition to the annual registration fee and by such
11 documentation as the department shall require, the department
12 shall issue to the person a special registration plate
13 designating the vehicle so licensed as belonging to a person who
14 is a recipient of the Bronze Star. The special registration
15 plate may be used only on a passenger car or truck with a
16 registered gross weight of not more than 14,000 pounds.

17 § 1368. Special plates for recipient of Bronze Star for Valor.

18 Upon application of any person who is a recipient of the
19 Bronze Star for Valor, accompanied by a fee of \$10 which shall
20 be in addition to the annual registration fee and by such
21 documentation as the department shall require, the department
22 shall issue to the person a special registration plate
23 designating the vehicle so licensed as belonging to a person who
24 is a recipient of the Bronze Star for Valor. The special
25 registration plate may be used only on a passenger car or truck
26 with a registered gross weight of not more than 14,000 pounds.

27 § 1369. SPECIAL PLATES FOR RECIPIENTS OF DISTINGUISHED SERVICE
28 CROSS, DISTINGUISHED FLYING CROSS, NAVY CROSS OR AIR
29 FORCE CROSS.

30 UPON APPLICATION OF ANY PERSON WHO IS A RECIPIENT OF THE



1 DISTINGUISHED SERVICE CROSS, DISTINGUISHED FLYING CROSS, NAVY
2 CROSS OR AIR FORCE CROSS, ACCOMPANIED BY A FEE OF \$10 WHICH
3 SHALL BE IN ADDITION TO THE ANNUAL REGISTRATION FEE AND BY SUCH
4 DOCUMENTATION AS THE DEPARTMENT SHALL REQUIRE, THE DEPARTMENT
5 SHALL ISSUE TO THE PERSON A SPECIAL REGISTRATION PLATE
6 DESIGNATING THE VEHICLE SO LICENSED AS BELONGING TO A PERSON WHO
7 IS A RECIPIENT OF THE DISTINGUISHED SERVICE CROSS, DISTINGUISHED
8 FLYING CROSS, NAVY CROSS OR AIR FORCE CROSS. THE SPECIAL
9 REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER CAR OR TRUCK
10 WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 14,000 POUNDS.

11 Section 2. This act shall take effect in 120 days.
