## AN ACT

8	Section 1. Sections 1141 and 1142 of the act of February 1,
9	1966 (1965 P.L.1656, No.581), known as The Borough Code, are

11	Section 1141. Borough Manager May be Created by Ordinance;
12	ElectionThe council of any borough may, at its discretion at
13	any time, create by ordinance the office of borough manager and
14	may in like manner abolish the same. While said office exists,
15	the council shall, from time to time, and whenever there is a
16	vacancy, elect, by a vote of a majority of all the members, one
17	person to fill said office[, subject to removal by the council
18	at any time by a vote of the majority of all the members]. <u>The</u>
19	borough manager shall serve at the pleasure of council, subject

1 to contractual rights that may arise under an employment agreement that may be entered in accordance with section 1142. 2 Section 1142. Powers and Duties; Bond.--The powers and 3 duties of the borough manager shall be regulated by ordinance. 4 Council may enter into an employment agreement with the borough 5 manager. The employment agreement may set forth the terms and 6 conditions of employment, and the agreement may provide that it 7 shall remain in effect for a specified period terminating no 8 9 later than two years after the effective date of the agreement 10 or the date of the organization meeting of council following the next municipal election, whichever shall first occur. An 11 12 employment agreement entered into pursuant to this section may 13 specify conditions under which a borough manager would be 14 entitled to severance compensation, but in no event shall an 15 employment agreement guarantee employment through the term of 16 the agreement or confer upon the borough manager any legal 17 remedy based on specific performance. The council, by ordinance, 18 may delegate, subject to recall, any of the nonlegislative and nonjudicial powers and duties of the council, the planning 19 20 commission and the shade tree commission, to the borough 21 manager. With approval of borough council, the mayor may 22 delegate to the borough manager any of his nonlegislative and nonjudicial powers and duties. 23
