AN ACT

- 1 Establishing standards for preventing sudden cardiac arrest and 2 death in student athletes; assigning duties to the Department
- of Health and the Department of Education; and imposing
- 4 penalties.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Sudden
- 9 Cardiac Arrest Prevention Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Athletic activity." All of the following:
- 15 (1) Interscholastic athletics.
- 16 (2) An athletic contest or competition, other than

- 1 interscholastic athletics, that is sponsored by or associated
- with a school entity, including cheerleading, club-sponsored
- 3 sports activities and sports activities sponsored by school-
- 4 affiliated organizations.
- 5 (3) Noncompetitive cheerleading that is sponsored by or
- 6 associated with a school entity.
- 7 (4) Practices, interschool practices and scrimmages for
- 8 all of the activities listed under paragraphs (1), (2) and
- 9 (3).
- 10 "Department." The Department of Health of the Commonwealth.
- "Interscholastic athletics." As defined in section 1602-A of
- 12 the act of March 10, 1949 (P.L.30, No.14), known as the Public
- 13 School Code of 1949.
- "School entity." As defined in section 1602-A of the act of
- 15 March 10, 1949 (P.L.30, No.14), known as the Public School Code
- 16 of 1949.
- 17 Section 3. Sudden cardiac arrest.
- 18 (a) Educational materials.--
- 19 (1) The department and the Department of Education shall
- develop and post on their publicly accessible Internet
- 21 websites guidelines and other relevant materials to inform
- 22 and educate students participating in or desiring to
- participate in an athletic activity, their parents and their
- 24 coaches about the nature and warning signs of sudden cardiac
- arrest, including the risks associated with continuing to
- 26 play or practice after experiencing the following symptoms:
- 27 fainting, difficulty breathing, chest pains, dizziness and
- 28 racing heart rate.
- 29 (2) In developing the guidelines and materials, the
- department and the Department of Education may utilize

- 1 existing materials developed by organizations, such as Parent
- 2 Heart Watch and Sudden Arrhythmia Death Syndromes.
- 3 (3) A student participating in or desiring to
- 4 participate in an athletic activity and the student's parent
- or guardian shall, each school year and prior to
- 6 participation by the student in an athletic activity, sign
- 7 and return to the student's school an acknowledgment of
- 8 receipt and review of the sudden cardiac arrest symptoms and
- 9 warning sign information sheet developed under this
- 10 subsection.
- 11 (b) Informational meeting. -- A school entity may hold an
- 12 informational meeting prior to the start of each athletic season
- 13 for all ages of competitors regarding the symptoms and warning
- 14 signs of sudden cardiac arrest. In addition to students,
- 15 parents, coaches and other school officials, informational
- 16 meetings may include physicians, pediatric cardiologists and
- 17 athletic trainers.
- 18 (c) Removal from play.--
- 19 (1) A student who, as determined by a game official,
- 20 coach from the student's team, certified athletic trainer,
- 21 licensed physician or other official designated by the
- student's school entity, exhibits signs or symptoms of sudden
- 23 cardiac arrest while participating in an athletic activity
- shall be removed by the coach from participation at that
- 25 time.
- 26 (2) If a student is known to have exhibited signs or
- 27 symptoms of sudden cardiac arrest at any time prior to or
- following an athletic activity, the student shall be
- 29 prevented from participating in an athletic activity.
- 30 (3) The student shall not return to participation in an

- 1 athletic activity until the student is evaluated and cleared
- for return to participation in writing by an appropriate
- 3 medical professional.
- 4 (4) In order to help determine whether a student is
- 5 ready to return to play, the appropriate medical professional
- 6 may consult any other licensed or certified medical
- 7 professionals.
- 8 (d) Training course.--
- 9 (1) Once each school year, a coach of an athletic
- 10 activity shall complete the sudden cardiac arrest training
- 11 course offered by a provider approved by the department.
- 12 (2) A coach of an athletic activity shall not coach the
- athletic activity until the coach completes the training
- 14 course required under this subsection.
- 15 (e) Penalties. -- The governing body of a school entity shall
- 16 establish the following minimum penalties for a coach found in
- 17 violation of the requirements under subsection (c), which
- 18 penalties shall take effect two years following the effective
- 19 date of this section:
- 20 (1) For a first violation, suspension from coaching any
- 21 athletic activity for the remainder of the season.
- 22 (2) For a second violation, suspension from coaching any
- 23 athletic activity for the remainder of the season and for the
- 24 next season.
- 25 (3) For a third violation, permanent suspension from
- 26 coaching any athletic activity.
- 27 (f) Other youth athletic activities. -- The sponsors of youth
- 28 athletic activities are encouraged to follow the guidance stated
- 29 in this act.
- 30 (g) Construction. -- Nothing in this act shall be construed

- 1 to:
- 2 (1) abridge or limit any rights provided under a
- 3 collective bargaining agreement or any rights provided under
- 4 the act of July 23, 1970 (P.L.563, No.195), known as the
- 5 Public Employe Relations Act; or
- 6 (2) create, establish, expand, reduce, contract or
- 7 eliminate any civil liability on the part of any school
- 8 entity or school employee.
- 9 Section 4. Effective date.
- 10 This act shall take effect in 60 days.
