AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, further providing for concealing death
- of child.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 4303(a) of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended and the section is amended by
- 8 adding a subsection to read:
- 9 § 4303. Concealing death of child.
- 10 (a) Offense defined. -- A person is guilty of a [misdemeanor
- 11 of the first degree] <u>felony of the third degree</u> if he or she <u>as</u>
- 12 <u>a parent</u> endeavors privately, either alone or by the procurement
- 13 of others, to conceal the death of his or her child, so that it
- 14 may not come to light, whether it was born dead or alive or

- 1 whether it was murdered or not.

- 3 (c) Definitions. -- As used in this section, the following
- 4 words and phrases shall have the meanings given to them in this
- 5 <u>subsection unless the context clearly indicates otherwise:</u>
- 6 <u>"Parent." A natural parent, stepparent, adoptive parent,</u>
- 7 guardian or custodian of a child, A PERSON RESPONSIBLE FOR THE
- 8 CHILD'S WELFARE, ANY INDIVIDUAL RESIDING IN THE SAME HOME AS THE
- 9 CHILD OR A PARAMOUR OF THE CHILD'S PARENT.
- 10 Section 2. This act shall take effect in 60 days.
