AN ACT

- 1 Amending Title 34 (Game) of the Pennsylvania Consolidated
- 2 Statutes, further providing for elk hunting licenses.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Section 2706.2 of Title 34 of the Pennsylvania
- 6 Consolidated Statutes is amended by adding subsections to read:
- 7 § 2706.2. Elk hunting licenses.
- 8 * * *
- 9 (c) Elk management area raffle.--If the commission awards
- 10 the opportunity to purchase elk hunting licenses in this
- 11 Commonwealth, other than the license auction authorized under
- 12 <u>subsection</u> (b), the commission shall conduct an elk management
- 13 area raffle. The raffle shall be subject to the following:
- 14 (1) The opportunity to purchase one license shall be
- awarded annually through the raffle.
- 16 (2) Only residents of the elk management area shall be
- 17 eligible to participate in the raffle.

- 1 (3) The opportunity to purchase an antlered elk hunting
- 2 <u>license shall be awarded through the raffle in even-numbered</u>
- 3 <u>years and the opportunity to purchase an antlerless elk</u>
- 4 <u>hunting license shall be awarded through the raffle in</u>
- 5 <u>odd-numbered years.</u>
- 6 (4) The raffle shall be conducted prior to any other
- awarding of the opportunity to purchase elk hunting licenses,
- 8 <u>with the exception of the license auction held under</u>
- 9 <u>subsection (b).</u>
- 10 (5) Except as otherwise provided by law, all applicants
- in the elk management area raffle, other than the person
- 12 <u>selected in the elk management area raffle, shall be eligible</u>
- for any other award of an opportunity to purchase an elk
- 14 <u>hunting license.</u>
- 15 (d) Definitions. -- The following words and phrases when used
- 16 in this section shall have the meanings given to them in this
- 17 subsection unless the context clearly indicates otherwise:
- 18 "Elk management area." The term as defined in 58 Pa. Code §
- 19 141.48 (relating to elk management area and elk hunt zones).
- 20 Section 2. This act shall take effect immediately.
