- 7 This act shall be known and may be cited as the Capital
- 8 Budget Act of 2011 for Highways Damaged by Hurricane Irene and
- 9 Tropical Storm Lee.
- 10 Section 2. Authorization.
- 11 The total authorization for the capital projects in the
- 12 category of highway projects itemized in sections 4 through 70
- 13 and to be constructed by the Department of Transportation, its
- 14 successors or assigns, and to be financed from current revenue
- 15 of the Motor License Fund shall be \$66,783,000.
