## AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated  
2 Statutes, IN GENERAL PROVISIONS, FURTHER PROVIDING FOR ←  
3 DEFINITIONS; IN REGISTRATION OF VEHICLES, FURTHER PROVIDING  
4 FOR VEHICLES EXEMPT FROM REGISTRATION; IN FEES, FURTHER  
5 PROVIDING FOR FARM VEHICLES; IN INSPECTION OF VEHICLES,  
6 FURTHER PROVIDING FOR REQUIREMENT FOR PERIODIC INSPECTION OF  
7 VEHICLES AND FOR OPERATION OF VEHICLE WITHOUT OFFICIAL  
8 CERTIFICATE OF INSPECTION; AND, IN SIZE, WEIGHT AND LOAD,  
9 further providing for width of vehicles.

10 The General Assembly of the Commonwealth of Pennsylvania  
11 hereby enacts as follows:

15 SECTION 1. THE DEFINITIONS OF "COMMERCIAL IMPLEMENT OF ←  
16 HUSBANDRY" AND "MULTIPURPOSE AGRICULTURAL VEHICLE" IN SECTION  
17 102 OF TITLE 75 OF THE PENNSYLVANIA CONSOLIDATED STATUTES ARE  
18 AMENDED TO READ:

1 § 102. DEFINITIONS.

2 SUBJECT TO ADDITIONAL DEFINITIONS CONTAINED IN SUBSEQUENT  
3 PROVISIONS OF THIS TITLE WHICH ARE APPLICABLE TO SPECIFIC  
4 PROVISIONS OF THIS TITLE, THE FOLLOWING WORDS AND PHRASES WHEN  
5 USED IN THIS TITLE SHALL HAVE, UNLESS THE CONTEXT CLEARLY  
6 INDICATES OTHERWISE, THE MEANINGS GIVEN TO THEM IN THIS SECTION:

8 "COMMERCIAL IMPLEMENT OF HUSBANDRY." AN IMPLEMENT OF  
9 HUSBANDRY THAT:

10 (1) IS A SELF-PROPELLED VEHICLE.

11 (2) IS USED [COMMERCIALY] TO PERFORM AGRICULTURAL  
12 PRODUCTION OR HARVESTING ACTIVITIES EXCLUSIVELY ON FARMS  
13 OTHER THAN FARMS OWNED OR OPERATED BY THE OWNER OF THE  
14 IMPLEMENT OF HUSBANDRY.

15 [(3) IS OPERATED OR MOVED UPON HIGHWAYS FOR NOT MORE  
16 THAN 180 DAYS IN A CALENDAR YEAR.]

17 THE TERM ALSO INCLUDES ANY OTHER VEHICLE DETERMINED BY THE  
18 DEPARTMENT TO BE A COMMERCIAL IMPLEMENT OF HUSBANDRY.

20 "MULTIPURPOSE AGRICULTURAL VEHICLE." A MOTOR VEHICLE WHICH  
21 IS [60] 62 INCHES OR LESS IN WIDTH AND [1,200] 2,000 POUNDS OR  
22 LESS IN DRY WEIGHT AND WHICH IS USED EXCLUSIVELY FOR  
23 AGRICULTURAL OPERATIONS AND ONLY INCIDENTALLY OPERATED OR MOVED  
24 UPON THE HIGHWAYS.

26 SECTION 2. SECTION 1302(2), (10) AND (17) OF TITLE 75 ARE  
27 AMENDED AND THE SECTION IS AMENDED BY ADDING PARAGRAPHS TO READ:  
28 § 1302. VEHICLES EXEMPT FROM REGISTRATION.

29 THE FOLLOWING TYPES OF VEHICLES ARE EXEMPT FROM REGISTRATION:

1            [(2) ANY IMPLEMENT OF HUSBANDRY, TRAILER OR SEMITRAILER  
2 DETERMINED BY THE DEPARTMENT TO BE USED EXCLUSIVELY FOR  
3 AGRICULTURAL OPERATIONS AND ONLY INFREQUENTLY OPERATED UPON  
4 HIGHWAYS. VEHICLES EXEMPT FROM REGISTRATION UNDER THIS  
5 PARAGRAPH SHALL BE USED EXCLUSIVELY UPON A FARM OR FARMS  
6 OWNED OR OPERATED BY THE OWNER OF THE VEHICLE OR UPON  
7 HIGHWAYS BETWEEN:

8            (I) PARTS OF ONE SUCH FARM.

9            (II) SUCH FARMS LOCATED NOT MORE THAN 25 MILES  
10 APART.

11           (III) SUCH FARM OR FARMS AND A PLACE OF BUSINESS  
12 LOCATED WITHIN A RADIUS OF 25 MILES FROM SUCH FARM OR  
13 FARMS FOR THE PURPOSE OF BUYING OR SELLING AGRICULTURAL  
14 COMMODITIES OR SUPPLIES OR FOR DELIVERY, REPAIR OR  
15 SERVICING OF THE VEHICLE.]

16           (2.1) ANY IMPLEMENT OF HUSBANDRY, OTHER THAN A  
17 COMMERCIAL IMPLEMENT OF HUSBANDRY, USED EXCLUSIVELY FOR  
18 AGRICULTURAL OPERATIONS. VEHICLES ARE EXEMPT FROM  
19 REGISTRATION UNDER THIS PARAGRAPH WHEN OPERATED WITHIN 50  
20 MILES OF THE FARM OR FARMS OWNED OR OPERATED BY THE VEHICLE  
21 OWNER.

22           (2.2) ANY IMPLEMENT OF HUSBANDRY, TRAILER OR SEMITRAILER  
23 USED EXCLUSIVELY FOR AGRICULTURAL OPERATIONS WHEN BEING TOWED  
24 OR HAULED BY AN IMPLEMENT OF HUSBANDRY OR FARM VEHICLE WITHIN  
25 50 MILES OF THE FARM OR FARMS OWNED OR OPERATED BY THE OWNER  
26 OF THE TOWED OR HAULED VEHICLE.

28           (10) ANY FARM VEHICLE USED EXCLUSIVELY UPON A FARM OR  
29 FARMS OWNED OR OPERATED BY THE OWNER OF THE VEHICLE [.

30           (I) TYPE I--SUCH A FARM VEHICLE WHICH DOES NOT

1 QUALIFY AS A MOTOR CARRIER VEHICLE MAY BE DRIVEN UPON  
2 HIGHWAYS ONLY FROM SUNRISE TO SUNSET. HOWEVER, A FARM  
3 VEHICLE WHICH QUALIFIES AS A MOTOR CARRIER VEHICLE AND  
4 DISPLAYS A CURRENTLY VALID CERTIFICATE OF INSPECTION MAY  
5 BE DRIVEN UPON HIGHWAYS WITHOUT ANY RESTRICTION AS TO  
6 TIME. SUCH A FARM VEHICLE MAY ONLY BE DRIVEN ON HIGHWAYS  
7 BETWEEN:

8 (A) PARTS OF ONE SUCH FARM.

9 (B) SUCH FARMS LOCATED NOT MORE THAN 25 MILES  
10 APART.

11 (C) SUCH FARM OR FARMS AND A PLACE OF BUSINESS

4 (I.1) TYPE A--SUCH A FARM VEHICLE WITH A GROSS  
5 VEHICLE WEIGHT RATING NOT EXCEEDING 10,000 POUNDS MAY BE  
6 DRIVEN UPON HIGHWAYS ONLY FROM SUNRISE TO SUNSET AND  
7 BETWEEN:

8 (A) PARTS OF ONE SUCH FARM.

9 (B) SUCH FARMS LOCATED NOT MORE THAN 50 MILES  
10 APART.

11 (C) SUCH FARM OR FARMS AND A PLACE OF BUSINESS  
12 LOCATED WITHIN A RADIUS OF 50 MILES FROM SUCH FARM OR  
13 FARMS FOR THE PURPOSE OF BUYING OR SELLING  
14 AGRICULTURAL COMMODITIES OR SUPPLIES.

15 (D) SUCH FARM OR FARMS AND A PLACE OF BUSINESS  
16 LOCATED WITHIN A RADIUS OF 50 MILES FROM SUCH FARM OR  
17 FARMS FOR THE PURPOSE OF REPAIRING OR SERVICING OF  
18 THE FARM VEHICLE OR THE TRAILER OR SEMITRAILER BEING  
19 TOWED OR HAULED BY THE FARM VEHICLE.

20 (I.2) TYPE B--SUCH A FARM VEHICLE WITH A GROSS  
21 VEHICLE WEIGHT RATING OF GREATER THAN 10,000 POUNDS AND  
22 NOT EXCEEDING 17,000 POUNDS MAY BE DRIVEN UPON HIGHWAYS  
23 ONLY FROM SUNRISE TO SUNSET AND BETWEEN:

24 (A) PARTS OF ONE SUCH FARM.

25 (B) SUCH FARMS LOCATED NOT MORE THAN 25 MILES  
26 APART.

27 (C) SUCH FARM OR FARMS AND A PLACE OF BUSINESS  
28 LOCATED WITHIN A RADIUS OF 25 MILES FROM SUCH FARM OR  
29 FARMS FOR THE PURPOSE OF BUYING OR SELLING  
30 AGRICULTURAL COMMODITIES OR SUPPLIES.

1           (D) SUCH FARM OR FARMS AND A PLACE OF BUSINESS  
2           LOCATED WITHIN A RADIUS OF 50 MILES FROM SUCH FARM OR  
3           FARMS FOR THE PURPOSE OF REPAIRING OR SERVICING OF  
4           THE FARM VEHICLE OR THE TRAILER OR SEMITRAILER BEING  
5           TOWED OR HAULED BY THE FARM VEHICLE.

6           (I.3) TYPE C--SUCH A FARM VEHICLE WHICH DOES QUALIFY  
7           AS A MOTOR CARRIER VEHICLE AND WHICH DOES NOT DISPLAY A  
8           CURRENTLY VALID CERTIFICATE OF INSPECTION MAY BE DRIVEN  
9           UPON HIGHWAYS ONLY FROM SUNRISE TO SUNSET AND BETWEEN:

10           (A) PARTS OF ONE SUCH FARM.

11           (B) SUCH FARMS LOCATED NOT MORE THAN TEN MILES  
12           APART.

13           (C) SUCH FARM OR FARMS AND A PLACE OF BUSINESS  
14           LOCATED WITHIN A RADIUS OF TEN MILES FROM SUCH FARM  
15           OR FARMS FOR THE PURPOSE OF BUYING OR SELLING  
16           AGRICULTURAL COMMODITIES OR SUPPLIES.

17           (D) SUCH FARM OR FARMS AND A PLACE OF BUSINESS  
18           LOCATED WITHIN A RADIUS OF 25 MILES FROM SUCH FARM OR  
19           FARMS FOR THE PURPOSE OF REPAIRING OR SERVICING OF  
20           THE FARM VEHICLE OR THE TRAILER OR SEMITRAILER BEING  
21           TOWED OR HAULED BY THE FARM VEHICLE.

22           (I.4) TYPE D--SUCH A FARM VEHICLE WHICH DOES QUALIFY  
23           AS A MOTOR CARRIER VEHICLE AND DISPLAYS A CURRENTLY VALID  
24           CERTIFICATE OF INSPECTION MAY BE DRIVEN WITHOUT ANY  
25           RESTRICTION AS TO TIME BUT MAY ONLY BE DRIVEN ON HIGHWAYS  
26           BETWEEN:

27           (A) PARTS OF ONE SUCH FARM.

28           (B) SUCH FARMS LOCATED NOT MORE THAN 50 MILES  
29           APART.

30           (C) SUCH FARM OR FARMS AND A PLACE OF BUSINESS
