1 2 3 4	Authorizing AND DIRECTING the Department of General Services, with the approval of the Governor, to grant and convey to Susquehanna Township, certain lands in Susquehanna Township, Dauphin County.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Conveyance in Susquehanna Township, Dauphin County.
8	(a) AuthorizationThe Department of General Services, with
9	the approval of the Governor, is hereby authorized AND DIRECTED
10	on behalf of the Commonwealth of Pennsylvania to grant and
11	convey to Susquehanna Township certain lands of the Commonwealth
12	of Pennsylvania, at the Pennsylvania State Police Headquarters,
13	situate in Susquehanna Township, Dauphin County, for
14	consideration equal to fair market FAIR MARKET VALUE as
15	determined by an independent appraisal.
16	(b) Property descriptionThe property to be conveyed

17 pursuant to this section consists of 1,262 square feet bounded

1 and more particularly described as follows:

2 ALL THAT CERTAIN tract of land situate at the northeasterly 3 intersection of Elmerton Avenue, State Route 3026 and Kohn Road, T-318, in Susquehanna Township, Dauphin County, Pennsylvania in 4 accordance with a plan entitled "Exhibit C, Right-of-Way Plan, 5 for Commonwealth of Pennsylvania", dated May 2, 2012, prepared 6 by K&W Engineers and Consultants, Harrisburg, Pennsylvania, 7 8 Project No. 2003.042, Sheet 1 of 1, being more fully bounded and described as follows: 9

10 BEGINNING at a point on the westerly side of the existing 11 right-of-way line of Kohn Road T-318, opposite Point of

2 (c) Conditions. -- The conveyance shall be made under and 3 subject to all lawful and enforceable easements, servitudes and rights of others, including, but not confined to, streets, 4 roadways and rights of any telephone, telegraph, water, 5 electric, gas or pipeline companies, as well as under and 6 subject to any lawful and enforceable estates or tenancies 7 vested in third persons appearing of record, for any portion of 8 9 the land or improvements erected thereon.

10 (d) Restriction.--The conveyance shall be made under and subject to the condition, which shall be contained in the deed 11 12 of conveyance, that no portion of the property conveyed shall be 13 used as a licensed facility, as defined in 4 Pa.C.S. § 1103 14 (relating to definitions), or any other similar type of facility authorized under State law. The condition shall be a covenant 15 16 running with the land and shall be binding upon the Grantee, its 17 successors and assigns. Should the Grantee, its successors or 18 assigns, permit any portion of the property authorized to be 19 conveyed in this section to be used in violation of this 20 subsection, the title shall immediately revert to and revest in 21 the Grantor.

(e) Deed of conveyance.--The deed of conveyance shall be
executed by the Secretary of General Services in the name of the
Commonwealth.

25 (f) Costs and fees.--Costs and fees incidental to this 26 conveyance shall be borne by the Grantee.

(g) Alternate disposition SUNSET PROVISION.--In the event that an agreement of sale between the parties THIS CONVEYANCE is not executed within 12 months of the effective date of this section, the property may be disposed of in accordance with
