AN ACT

- Designating the portion of State Route 30, from Wynnewood Road to Station Road, in Lower Merion Township, Montgomery County,
- as the Master Sergeant Scott Ball Memorial Avenue.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Master Sergeant Scott Ball Memorial Avenue.
- 7 (a) Findings.--The General Assembly finds and declares as
- 8 follows:
- 9 (1) Master Sergeant Scott Ball was killed on August 27,
- 10 2007, when, while serving with the Pennsylvania Army National
- 11 Guard in Afghanistan, the embedded training team in which he
- served was ambushed while assisting the Afghan National Army.
- 13 (2) Master Sgt. Ball was a Pennsylvania State Police
- trooper assigned to Troop H, Carlisle.
- 15 (3) Prior to enlisting in the Pennsylvania State Police,

- 1 Master Sgt. Ball served the citizens of Lower Merion
- 2 Township, Montgomery County, as a Lower Merion Township
- 3 police officer from 1995-2000.
- 4 (b) Designation. -- The portion of State Route 30, from
- 5 Wynnewood Road to Station Road, in Lower Merion Township,
- 6 Montgomery County, is hereby designated as the Master Sergeant
- 7 Scott Ball Memorial Avenue.
- 8 (c) Signs.—The Department of Transportation shall erect and
- 9 maintain appropriate signs displaying the name of the highway to
- 10 traffic in both directions on the highway.
- 11 Section 2. Effective date.
- 12 This act shall take effect immediately.
