A RESOLUTION

- Designating March 2011 as "Professional Social Work Month" in Pennsylvania.
- 3 WHEREAS, The primary mission of social workers is to help
- 4 people who need assistance with social issues; and
- 5 WHEREAS, Social workers have the education and experience to
- 6 quide individuals, families and communities through complex
- 7 issues and choices; and
- 8 WHEREAS, Social workers hold bachelor's, master's or doctoral
- 9 social work degrees and have attained a minimum number of hours
- 10 in supervised fieldwork to become a licensed social worker; and
- 11 WHEREAS, More than 600,000 people in the United States hold
- 12 social work degrees; and
- 13 WHEREAS, Social workers connect individuals, families and
- 14 communities to available resources; and
- 15 WHEREAS, Social workers can be found in hospitals, police
- 16 departments, mental health clinics, child welfare agencies,

- 1 military facilities, adoption agencies, drug and alcohol
- 2 treatment facilities, schools and corporations; and
- 3 WHEREAS, Professional social workers are the nation's largest
- 4 provider of mental health services; and
- 5 WHEREAS, The United States Department of Veterans Affairs
- 6 employs more than 8,000 social workers to assist veterans and
- 7 their families with individual and family counseling, client
- 8 education, end-of-life planning, substance abuse treatment,
- 9 crisis intervention and other services; and
- 10 WHEREAS, Social workers are dedicated to improving the
- 11 society in which we live; and
- 12 WHEREAS, Social workers are positive and compassionate
- 13 professionals; and
- 14 WHEREAS, Social workers endeavor to make sure everyone has
- 15 access to the same basic rights, protections and opportunities;
- 16 and
- 17 WHEREAS, Social workers help people help themselves, whenever
- 18 and wherever they need it most; and
- 19 WHEREAS, Social workers are often the driving force behind
- 20 important social movements in the United States and abroad; and
- 21 WHEREAS, According to the Bureau of Labor Statistics, the
- 22 need for social workers is expected to grow faster than the
- 23 average for all occupations through 2018, especially in
- 24 gerontology, home health care, substance abuse, private social
- 25 service agencies and school social work; and
- 26 WHEREAS, As the need for social work services increases,
- 27 there will not be enough social workers to meet the needs of
- 28 their clients; therefore be it
- 29 RESOLVED, That the House of Representatives designate March
- 30 2011 as "Professional Social Work Month" in Pennsylvania and

- 1 call upon all citizens to join with the National Association of
- 2 Social Workers, Pennsylvania Chapter, to celebrate and support
- 3 social workers and the social work profession.
