A RESOLUTION

- Recognizing the volunteers participating in Keep Pennsylvania Beautiful's "Great American Cleanup of PA" March 1 through
- 3 May 31, 2011.
- 4 WHEREAS, The "Great American Cleanup of PA" is celebrating
- 5 its ninth anniversary of involving people all across this
- 6 Commonwealth in the cleanup of litter and trash along our
- 7 roadsides, streams, beaches, parks, forests and neighborhoods to
- 8 make our communities clean and beautiful; and
- 9 WHEREAS, Since 2003, more than 1.1 million volunteers have
- 10 participated in the cleanups, and last year alone more than
- 11 186,000 individuals, members of Adopt-A-Highway groups,
- 12 municipalities, conservation, school and youth groups,
- 13 businesses, hunting and fishing clubs, community and civic
- 14 organizations and sports teams were involved; and

- 1 WHEREAS, These cleanups have resulted in removing more than
- 2 54 million pounds of litter and waste from Pennsylvania's
- 3 landscape since 2003, including 12 million pounds of litter
- 4 during nearly 5,000 registered events in all 67 counties last
- 5 year; and
- 6 WHEREAS, The "Great American Cleanup of PA" was organized
- 7 with the help of a broad partnership of State agencies,
- 8 nonprofit groups, businesses and other associations, including
- 9 Keep America Beautiful, the Department of Environmental
- 10 Protection, the Department of Transportation, the Pennsylvania
- 11 Beverage Association, the Pennsylvania Food Merchants
- 12 Association, the Pennsylvania Waste Industries Association,
- 13 Waste Management, Inc., Keystone Sanitary Landfill, Inc., the
- 14 Steel Recycling Institute and the American Chemistry Council;

- 16 WHEREAS, The Department of Environmental Protection and the
- 17 Pennsylvania Waste Industries Association, including Keystone
- 18 Sanitary Landfill, Inc., and Waste Management, Inc., arrange for
- 19 the free disposal of trash collected during the special "Let's
- 20 Pick It Up PA Everyday" initiative from April 16 through 30,
- 21 2011, for groups registered in the "Great American Cleanup of
- 22 PA"; and
- 23 WHEREAS, The Department of Transportation and the Department
- 24 of Environmental Protection and national Keep America Beautiful
- 25 corporate sponsors provide free supplies to participants; and
- 26 WHEREAS, In 2011, the national Great American Cleanup
- 27 initiative of Keep America Beautiful held its kickoff event in
- 28 Philadelphia to showcase the city's 250 volunteer cleanup
- 29 events; and
- 30 WHEREAS, In 2010, Keep America Beautiful recognized the

- 1 Department of Transportation for its exemplary contributions and
- 2 support of the "Great American Cleanup of PA" and the national
- 3 Great American Cleanup for the eighth year in a row; and
- 4 WHEREAS, In 2010, Keep America Beautiful recognized Keep
- 5 Pennsylvania Beautiful for 100% county participation in the
- 6 "Great American Cleanup of PA"; therefore be it
- 7 RESOLVED, That the House of Representatives recognize the
- 8 more than 186,000 volunteers, Keep Pennsylvania Beautiful and
- 9 all the participating and supporting agencies and organizations
- 10 of the "Great American Cleanup of PA" and "Let's Pick It Up PA -
- 11 Everyday" initiatives for their contributions to keep
- 12 Pennsylvania beautiful.
