A RESOLUTION

- Designating the month of April 2012 as "Sexual Assault Awareness Month" in Pennsylvania.
- 3 WHEREAS, Sexual violence consists of a range of unacceptable
- 4 behaviors, including rape, incest, molestation, date and
- 5 acquaintance rape, statutory rape, marital or partner rape,
- 6 ritual abuse, sexual exploitation, forced prostitution, indecent
- 7 sexual contact, sexual harassment, exhibitionism and voyeurism;
- 8 and
- 9 WHEREAS, One in five girls and one in six boys will be
- 10 sexually assaulted by 18 years of age; and
- 11 WHEREAS, In the United States, it is estimated that more than
- 12 876,000 adult women and 111,200 adult men each year are
- 13 subjected to the traumatic experience of being raped; and
- 14 WHEREAS, Victims of sexual violence are more likely to
- 15 experience long-term mental health consequences, including

- 1 suicide and attempted suicide, eating disorders, substance
- 2 abuse, promiscuity, low self-esteem, psychiatric
- 3 hospitalizations and post-traumatic stress disorder; and
- 4 WHEREAS, The Centers for Disease Control and Prevention has
- 5 identified sexual violence as an urgent and costly public health
- 6 crisis; and
- 7 WHEREAS, The American Medical Association has stated that
- 8 sexual violence is a silent, violent epidemic which is growing
- 9 at alarming rates and traumatizing the women, men and children
- 10 of this nation; and
- 11 WHEREAS, The Federal Bureau of Investigation and other law
- 12 enforcement agencies across the nation indicate that sexual
- 13 violence is the most underreported crime in the United States,
- 14 with only an average of 31% of rape and sexual assault incidents
- 15 being reported to police; therefore be it
- 16 RESOLVED, That the House of Representatives designate the
- 17 month of April 2012 as "Sexual Assault Awareness Month" in
- 18 Pennsylvania and recognize that it is time to take action
- 19 against sexual violence by uniting the efforts of all who work
- 20 on behalf of victims of sexual violence to educate individuals
- 21 to prevent sexual violence and to eliminate sexual crimes in our
- 22 communities.
