A RESOLUTION

1 2	Recognizing the month of April 2012 as "National County Government Month" in Pennsylvania.
3	WHEREAS, National County Government Month serves to raise
4	public awareness and understanding about the roles and
5	responsibilities of the nation's counties to meet the needs of
6	the community; and
7	WHEREAS, During this month, county officials will initiate
8	outreach activities to assemble groups at high schools,
9	libraries, malls, shopping centers and colleges to educate
10	residents about county services and will meet with members of
11	the Congress of the United States to discuss the needs and state
12	of affairs concerning county government; and
13	WHEREAS, First held in 1991 as National County Government
14	Week and later changed in 2010 to National County Government

Month, this observance is sponsored annually by the National
Association of Counties (NACo), which is the only national
organization that represents county governments in the United
States; and

5 WHEREAS, There are 67 counties in the Commonwealth of 6 Pennsylvania and 3,068 counties nationwide, serving 300 million 7 Americans; and

8 WHEREAS, Pennsylvania counties serve a vital function in 9 providing for health care, law enforcement, judicial 10 administration, corrections and criminal justice programs; and 11 WHEREAS, Pennsylvania counties are involved in the conduct 12 and oversight of elections, which are the foundation of our 13 democracy; and

14 WHEREAS, To improve Pennsylvania's communities, counties in 15 the Commonwealth of Pennsylvania are involved in regional and 16 environmental planning and economic development and may 17 establish housing and redevelopment authorities and conduct 18 community development programs; and

19 WHEREAS, Counties are responsible for real estate tax 20 assessment, are involved in solid waste disposal and may support 21 local libraries and community colleges; and

22 WHEREAS, Counties are directly involved in the dispensation 23 of public health care, as they provide protective services for 24 children and youth, mental health and mental retardation 25 programs and drug and alcohol awareness programs and maintain 26 hospitals and homes for the aged; and

27 WHEREAS, Counties embrace the responsibility of protecting 28 and enhancing the health, welfare and safety of residents in 29 sensible and cost-effective ways; and

30 WHEREAS, This year's theme is "Healthy Counties, Healthy

Families," which encourages counties to promote healthy living 1 2 and lifestyle choices in communities across the country; and 3 WHEREAS, In an effort to bolster this theme, NACo President Lenny Eliason has adopted a "Healthy Counties" initiative, which 4 5 seeks to enhance public and private partnerships related to the delivery of local health care services to improve the overall 6 quality of health care and assist counties in effectively 7 8 implementing Federal health care reform; therefore be it 9 RESOLVED, That the House of Representatives of the 10 Commonwealth of Pennsylvania recognize the month of April 2012 11 as "National County Government Month" in Pennsylvania and 12 commend the counties in the Commonwealth of Pennsylvania for 13 sponsoring events to help residents better understand how 14 counties serve the community; and be it further

15 RESOLVED, That the House of Representatives of the 16 Commonwealth of Pennsylvania commend the National Association of 17 Counties' Healthy Counties Advisory Board for its work in 18 increasing the public's awareness regarding the important and 19 extensive role that counties play in serving the health care 20 needs of its citizens; and be it further

21 RESOLVED, That the House of Representatives of the 22 Commonwealth of Pennsylvania call on the citizens of 23 Pennsylvania to participate in this month's activities and 24 encourage them to reflect upon the numerous essential public 25 health services provided by the counties in the Commonwealth of 26 Pennsylvania and the nation; and be it further
