## AN ACT

- Amending the act of February 1, 1966 (1965 P.L.1656, No.581), entitled "An act concerning boroughs, and revising, amending
- 2
- and consolidating the law relating to boroughs," further 3
- providing for regulation of contracts, for evasion of
- advertising requirements and certain purchase contracts. 5
- 6 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 8 Section 1. Section 1402(a), (a.1) and (d) of the act of
- February 1, 1966 (1965 P.L.1656, No.581), known as The Borough
- Code, amended or added July 10, 1990 (P.L.383, No.90), December 10
- 18, 1996 (P.L.1141, No.171), December 18, 1996 (P.L.1156, No. 11
- 12 176), December 20, 1996 (P.L.1497, No.193) and October 27, 2010
- (P.L. , No.87), are amended and the section is amended by 13
- 14 adding a subsection to read:
- 15 Section 1402. Regulation of Contracts. -- (a) All contracts
- 16 or purchases in excess of [ten thousand dollars (\$10,000)]
- 17 twenty five thousand dollars (\$25,000) THE BASE AMOUNT OF

- 1 EIGHTEEN THOUSAND FIVE HUNDRED DOLLARS (\$18,500) subject to
- 2 adjustment under subsection (a.2), except those hereinafter
- 3 mentioned, shall not be made except with and from the lowest
- 4 responsible bidder after due notice in one newspaper of general
- 5 circulation in the borough, at least two times at intervals of
- 6 not less than three days where daily newspapers of general
- 7 circulation are available for such publication, in case of
- 8 weekly newspapers, such notice once a week for two successive
- 9 weeks. The first advertisement shall be published not more than
- 10 forty-five days and the second advertisement not less than ten
- 11 days prior to the date fixed for the opening of bids.
- 12 Advertisements for contracts or purchases shall also be posted
- 13 in a conspicuous place within the borough. Advertisements for
- 14 contracts and purchases shall contain the date, time and
- 15 location for opening of bids and shall state the amount of the
- 16 performance bond determined under subsection (c). The amount of
- 17 the contract shall in all cases, whether of straight sale price,
- 18 conditional sale, bailment lease, or otherwise, be the entire
- 19 amount which the borough pays to the successful bidder or his
- 20 assigns in order to obtain the services or property, or both,
- 21 and shall not be construed to mean only the amount which is paid
- 22 to acquire title or to receive any other particular benefit or
- 23 benefits of the whole bargain. In awarding contracts, council
- 24 shall have the right to take into consideration such other
- 25 factors as the availability, cost and quality of service.
- 26 (a.1) Written or telephonic price quotations from at least
- 27 three qualified and responsible contractors shall be requested
- 28 for all contracts [that exceed +four thousand dollars (\$4,000)]
- 29 seven thousand dollars (\$7,000) IN EXCESS OF THE BASE AMOUNT OF
- 30 TEN THOUSAND DOLLARS (\$10,000) subject to adjustment under

- 1 <u>subsection (a.2)</u> but are less than the amount requiring
- 2 advertisement and competitive bidding or, in lieu of price
- 3 quotations, a memorandum shall be kept on file showing that
- 4 fewer than three qualified contractors exist in the market area
- 5 within which it is practicable to obtain quotations. A written
- 6 record of telephonic price quotations shall be made and shall
- 7 contain at least the date of the quotation, the name of the
- 8 contractor and the contractor's representative, the
- 9 construction, reconstruction, repair, maintenance or work which
- 10 was the subject of the quotation and the price. Written price
- 11 quotations, written records of telephonic price quotations and
- 12 memoranda shall be retained for a period of three years.
- 13 (a.2) (1) Every five years, beginning with the year in
- 14 which this subsection becomes applicable to contracts and
- 15 purchases, the Department of Labor and Industry shall calculate
- 16 <u>the average percentage change in the Consumer Price Index for</u>
- 17 All Urban Consumers (CPI U) for the United States city average
- 18 for all items as published by the United States Department of
- 19 Labor, Bureau of Labor Statistics, for the preceding five year
- 20 <del>period.</del>
- 21 (2) The amount at which competitive bidding is required
- 22 under subsection (a) and the amount at which written or
- 23 telephonic price quotations are required under subsection (a.1)
- 24 <u>shall be adjusted every five years as follows:</u>
- 25 (i) In the case of competitive bidding, the positive
- 26 percentage change, as determined in accordance with clause (1),
- 27 shall be multiplied by the amount applicable under subsection
- 28 (a) for the current five year period and the product thereof
- 29 shall be added to the amount applicable under subsection (a) for
- 30 the current five year period, with the result rounded to the

- 1 nearest multiple of one hundred dollars (\$100).
- 2 (ii) In the case of written or telephonic price quotations,
- 3 the positive percentage change, as determined in accordance with
- 4 <u>clause (1), shall be multiplied by the amount applicable under</u>
- 5 subsection (a.1) for the current five-year period and the
- 6 product thereof shall be added to the amount applicable under
- 7 <u>subsection (a.1) for the current five-year period, with the</u>
- 8 result rounded to the nearest multiple of one hundred dollars
- 9 <del>(\$100).</del>
- 10 (3) The determination required under clause (1) and the
- 11 <u>calculation of the adjustments required under clause (2) shall</u>
- 12 <u>be made in the period between October 1 and November 15 of the</u>
- 13 <u>year following the effective date of this subsection, and</u>
- 14 between October 1 and November 15 of each successive year.
- 15 (4) The adjusted amounts obtained in accordance with clause
- 16 <u>(2) shall become effective January 1 for the five year period</u>
- 17 following the year in which the determination required under
- 18 clause (1) is made.
- 19 (5) The Department of Labor and Industry shall give notice
- 20 in the Pennsylvania Bulletin prior to January 1 of each calendar
- 21 <u>vear\_in which the percentage change determined in accordance</u>
- 22 with clause (1) and the amounts, whether adjusted or unadjusted
- 23 <u>in accordance with clause (2), at which competitive bidding is</u>
- 24 required under subsection (a) and written or telephonic price
- 25 quotations are required under subsection (a.1) for the five year
- 26 period beginning the first day of January after publication of
- 27 the notice.
- 28 (A.2) ADJUSTMENTS TO THE BASE AMOUNTS SPECIFIED UNDER
- 29 SUBSECTIONS (A) AND (A.1) SHALL BE MADE AS FOLLOWS:
- 30 (1) THE DEPARTMENT OF LABOR AND INDUSTRY SHALL DETERMINE THE

- 1 PERCENTAGE CHANGE IN THE ALL ITEMS CONSUMER PRICE INDEX FOR ALL
- 2 URBAN CONSUMERS (CPI-U) FOR THE UNITED STATES CITY AVERAGE AS
- 3 PUBLISHED BY THE UNITED STATES DEPARTMENT OF LABOR, BUREAU OF
- 4 LABOR STATISTICS FOR THE TWELVE-MONTH PERIOD ENDING SEPTEMBER
- 5 30, 2012, AND FOR EACH SUCCESSIVE TWELVE-MONTH PERIOD
- 6 THEREAFTER.
- 7 (2) IF THE DEPARTMENT DETERMINES THAT THERE IS NO POSITIVE
- 8 PERCENTAGE CHANGE, THEN NO ADJUSTMENT TO THE BASE AMOUNTS SHALL
- 9 OCCUR FOR THE RELEVANT TIME PERIOD PROVIDED FOR IN THIS
- 10 SUBSECTION.
- 11 (3) (I) IF THE DEPARTMENT DETERMINES THAT THERE IS A
- 12 POSITIVE PERCENTAGE CHANGE IN THE FIRST YEAR THAT THE
- 13 DETERMINATION IS MADE UNDER PARAGRAPH (1), THE POSITIVE
- 14 PERCENTAGE CHANGE SHALL BE MULTIPLIED BY EACH BASE AMOUNT AND
- 15 THE PRODUCTS SHALL BE ADDED TO THE BASE AMOUNTS, RESPECTIVELY,
- 16 AND THE SUMS SHALL BE PRELIMINARY ADJUSTED AMOUNTS.
- 17 (II) THE PRELIMINARY ADJUSTED AMOUNTS SHALL BE ROUNDED TO
- 18 THE NEAREST ONE THOUSAND DOLLARS (\$1,000), TO DETERMINE THE
- 19 FINAL ADJUSTED BASE AMOUNTS FOR PURPOSES OF SUBSECTIONS (A) AND
- 20 (A.1).
- 21 (4) IN EACH SUCCESSIVE YEAR IN WHICH THERE IS A POSITIVE
- 22 PERCENTAGE CHANGE IN THE CPI-U FOR THE UNITED STATES CITY
- 23 AVERAGE, THE POSITIVE PERCENTAGE CHANGE SHALL BE MULTIPLIED BY
- 24 THE MOST RECENT PRELIMINARY ADJUSTED AMOUNTS AND THE PRODUCTS
- 25 SHALL BE ADDED TO THE PRELIMINARY ADJUSTED AMOUNT OF THE PRIOR
- 26 YEAR TO CALCULATE THE PRELIMINARY ADJUSTED AMOUNTS FOR THE
- 27 CURRENT YEAR. THE SUMS THEREOF SHALL BE ROUNDED TO THE NEAREST
- 28 ONE THOUSAND DOLLARS (\$1,000) TO DETERMINE THE NEW FINAL
- 29 ADJUSTED BASE AMOUNTS FOR PURPOSES OF SUBSECTIONS (A) AND (A.1).
- 30 (5) THE DETERMINATIONS AND ADJUSTMENTS REQUIRED UNDER THIS

- 1 SUBSECTION SHALL BE MADE IN THE PERIOD BETWEEN OCTOBER 1 AND
- 2 NOVEMBER 15 OF THE YEAR FOLLOWING THE EFFECTIVE DATE OF THIS
- 3 SUBSECTION, AND ANNUALLY BETWEEN OCTOBER 1 AND NOVEMBER 15 OF
- 4 <u>EACH YEAR THEREAFTER</u>.
- 5 (6) THE FINAL ADJUSTED BASE AMOUNTS AND NEW FINAL ADJUSTED
- 6 BASE AMOUNTS OBTAINED UNDER PARAGRAPHS (3) AND (4) SHALL BECOME
- 7 <u>EFFECTIVE JANUARY 1 FOR THE CALENDAR YEAR FOLLOWING THE YEAR IN</u>
- 8 WHICH THE DETERMINATION REQUIRED UNDER PARAGRAPH (1) IS MADE.
- 9 <u>(7) THE DEPARTMENT SHALL PUBLISH NOTICE IN THE PENNSYLVANIA</u>
- 10 BULLETIN PRIOR TO JANUARY 1 OF EACH CALENDAR YEAR OF THE ANNUAL
- 11 PERCENTAGE CHANGE DETERMINED UNDER PARAGRAPH (1) AND THE
- 12 UNADJUSTED OR FINAL ADJUSTED BASE AMOUNTS DETERMINED UNDER
- 13 PARAGRAPHS (3) AND (4) AT WHICH COMPETITIVE BIDDING IS REQUIRED
- 14 UNDER SUBSECTION (A) AND WRITTEN OR TELEPHONIC PRICE QUOTATIONS
- 15 ARE REQUIRED UNDER SUBSECTION (A.1), RESPECTIVELY, FOR THE
- 16 CALENDAR YEAR BEGINNING THE FIRST DAY OF JANUARY AFTER
- 17 PUBLICATION OF THE NOTICE. THE NOTICE SHALL INCLUDE A WRITTEN
- 18 AND ILLUSTRATIVE EXPLANATION OF THE CALCULATIONS PERFORMED BY
- 19 THE DEPARTMENT IN ESTABLISHING THE UNADJUSTED OR FINAL ADJUSTED
- 20 BASE AMOUNTS UNDER THIS SUBSECTION FOR THE ENSUING CALENDAR
- 21 YEAR.
- 22 (8) NO ADJUSTMENT TO THE BASE AMOUNTS SPECIFIED UNDER
- 23 SUBSECTIONS (A) AND (A.1) SHALL EXCEED THREE PERCENT OF THE MOST
- 24 RECENTLY ADJUSTED BASE AMOUNT.
- 25 \* \* \*
- 26 (d) The contracts or purchases made by council, which shall
- 27 not require advertising, bidding or price quotations as
- 28 hereinbefore provided, are as follows:
- 29 (1) Those for maintenance, repairs or replacements for
- 30 water, electric light or public works of the borough, provided

- 1 they do not constitute new additions, extensions or enlargements
- 2 of existing facilities and equipment, but a bond may be required
- 3 by council, as in other cases of work done;
- 4 (2) Those made for improvements, repairs and maintenance of
- 5 any kind, made or provided by any borough, through its own
- 6 employes: Provided, That all materials used for street
- 7 improvement, maintenance and/or construction in excess of [four
- 8 thousand dollars (\$4,000)] the amount specified or adjusted
- 9 <u>under subsection (a.1)</u> be subject to the relevant price
- 10 quotation or advertising requirements contained herein;
- 11 (3) Those where particular types, models or pieces of new
- 12 equipment, articles, apparatus, appliances, vehicles or parts
- 13 thereof are desired by council, which are patented and
- 14 manufactured or copyrighted products;
- 15 (3.1) Those for used equipment, articles, apparatus,
- 16 appliances, vehicles or parts thereof being purchased from a
- 17 public utility.
- 18 (4) Those involving any policies of insurance or surety
- 19 company bonds; those made for public utility service under
- 20 tariffs on file with the Pennsylvania Public Utility Commission;
- 21 those made with another political subdivision, or a county, the
- 22 Commonwealth of Pennsylvania, the Federal Government, any agency
- 23 of the Commonwealth or the Federal Government, or any municipal
- 24 authority, including the sale, leasing or loan of any supplies
- 25 or materials by the Commonwealth or the Federal Government or
- 26 their agencies. The price thereof shall not be in excess of that
- 27 fixed by the Commonwealth, the Federal Government, or their
- 28 agencies;
- 29 (5) Those involving personal or professional services.
- 30 (6) Those made relating to the purchase of electricity and

- 1 associated energy and related services by a borough owning or
- 2 operating electric generation or distribution facilities on the
- 3 effective date of this section with any of the following:
- 4 (i) A political subdivision.
- 5 (ii) Another state.
- 6 (iii) The Commonwealth or an agency thereof.
- 7 (iv) The Federal Government.
- 8 (v) A private corporation.
- 9 (vi) An electric cooperative corporation under 15 Pa.C.S.
- 10 Ch. 73 (relating to electric cooperative corporations).
- 11 (vii) A non-profit membership corporation. As used in this
- 12 subclause, the term "non-profit membership corporation" means an
- 13 entity, the membership of which:
- 14 (A) consists solely of Pennsylvania boroughs, such as a
- 15 consortium, buying group or municipal power agency under section
- 16 2471.2; or
- 17 (B) consists of Pennsylvania boroughs and political
- 18 subdivisions of another state or states.
- 19 (viii) An electric cooperative of another state.
- 20 Nothing in this clause shall prohibit council from engaging in
- 21 advertising, bidding or price quotations if the council
- 22 determines that the advertising, bidding or price quotations are
- 23 in the public interest.
- 24 \* \* \*
- 25 Section 2. Sections 1403(a) and 1405 of the act, amended
- 26 July 10, 1990 (P.L.383, No.90), are amended to read:
- 27 Section 1403. Evasion of Advertising Requirements. -- (a) No
- 28 member or members of council shall evade the provisions of
- 29 section 1402 hereof as to advertising for bids, by purchasing or
- 30 contracting for services and personal properties piecemeal for

- 1 the purpose of obtaining prices under [ten thousand dollars
- 2 (\$10,000)] the amount specified or adjusted under section
- 3 1402(a) upon transactions, which transactions should, in the
- 4 exercise of reasonable discretion and prudence, be conducted as
- 5 one transaction amounting to more than [ten thousand dollars
- 6 (\$10,000)] the amount specified or adjusted under section
- 7 1402(a). This provision is intended to make unlawful the evading
- 8 of advertising requirements by making a series of purchases or
- 9 contracts, each for less than the advertising requirement price,
- 10 or by making several simultaneous purchases or contracts, each
- 11 below said price, when, in either case, the transactions
- 12 involved should have been made as one transaction for one price.
- 13 Any members of council who so vote in violation of this
- 14 provision and who know that the transaction upon which they so
- 15 vote is or ought to be a part of a larger transaction and that
- 16 it is being divided in order to evade the requirements as to
- 17 advertising for bids, shall be jointly and severally subject to
- 18 surcharge for ten percent of the full amount of the contract or
- 19 purchase. Whenever it shall appear that a member of council may
- 20 have voted in violation of this section but the purchase or
- 21 contract on which he so voted was not approved by council, this
- 22 section shall be inapplicable.

- 24 Section 1405. Separate Bids for Plumbing, Heating,
- 25 Ventilating and Electrical Work. -- In the preparation for the
- 26 erection, construction and alteration of any public building,
- 27 when the entire cost of such work shall exceed [ten thousand
- 28 dollars (\$10,000)] the amount specified or adjusted under
- 29 <u>section 1402(a)</u>, the architect, engineer, or other person
- 30 preparing such specifications may, if so requested by the

- 1 borough council, prepare separate specifications for the
- 2 plumbing, heating, ventilating and electrical work. The person
- 3 or persons authorized to enter into contracts for the erection,
- 4 construction or alteration of such public buildings may, if such
- 5 separate specifications shall have been proposed, receive
- 6 separate bids upon each of the said branches of work and shall
- 7 thereupon award the contract for the same to the lowest
- 8 responsible bidder for each of said branches.
- 9 Section 3. This act shall apply to contracts and purchases
- 10 advertised after December 31 of the year in which this section
- 11 takes effect.
- 12 Section 4. This act shall take effect immediately.
