AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, providing for prohibiting use of electronic
- wireless communications devices while operating motor
- 4 vehicles.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 75 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 3316. Prohibiting use of electronic wireless communications
- 10 devices.
- 11 (a) Prohibition. -- Except as otherwise provided in this
- 12 <u>section</u>, no person shall operate a motor vehicle upon a public
- 13 highway and use an electronic wireless communications device to
- 14 send, read or write a text message while the vehicle is in
- 15 motion. A person does not send, read or write a text message
- 16 when the person reads, selects or enters a phone number or name
- 17 <u>in an electronic wireless communications device for the purpose</u>
- 18 of making a phone call. A conviction or detainment under this

- 1 <u>subsection</u> by State or local law enforcement agencies shall
- 2 <u>occur only as a secondary action when a driver of a motor</u>
- 3 vehicle has been detained or convicted of any other provision of
- 4 this title.
- 5 (b) Applicability. -- This section shall not apply to a person
- 6 operating:
- 7 <u>(1) an emergency vehicle; or</u>
- 8 (2) while in the performance of their official duties: a
- 9 police officer, peace officer or coroner; or a member of a
- fire department, district or company.
- 11 (c) Penalty. -- Any person who violates this section shall be
- 12 guilty of a summary offense with a maximum fine of \$100. A
- 13 <u>violation of subsection (a) shall not result in the accumulation</u>
- 14 of points under this title.
- 15 <u>(d) Local ordinances.--This section supersedes and preempts</u>
- 16 <u>all ordinances of any municipality with regard to the use of an</u>
- 17 electronic wireless communications device by the driver of a
- 18 motor vehicle.
- 19 (e) Definitions.--As used in this section, the following
- 20 words and phrases shall have the meanings given to them in this
- 21 subsection:
- 22 "Electronic wireless communications device." A handheld
- 23 electronic device that permits the user to send or receive
- 24 electronic communications but excludes a voice-activated global
- 25 positioning or navigation system affixed to the vehicle.
- 26 "Text message." A message consisting of words typed or
- 27 <u>entered on a keypad of the electronic wireless communication</u>
- 28 <u>device</u> and <u>sent</u> electronically.
- 29 Section 2. This act shall take effect in 60 days.
