1 2 3 4 5 6 7	Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," IN INTERMEDIATE UNITS, further providing for reports to Department of Education, for subsidies for services and for financial reports.
8	The General Assembly of the Commonwealth of Pennsylvania
9	hereby enacts as follows:
10	Section 1. Section 218 of act of March 10, 1949 (P.L.30,
11	No.14), known as the Public School Code of 1949, amended
12	November 17, 2010 (P.L.996, No.104), is amended to read:
13	Section 218. Reports to Department of Education. (a) An-
14	annual financial report shall be submitted to the Secretary of
15	Education by each school district, intermediate unit, charter
16	school, cyber charter school and area vocational technical
17	school not later than the 31st day of October. All financial
18	accounting and reporting by school districts, intermediate
19	units, charter schools, cyber charter schools and area
20	vocational technical schools to the Department of Education

- 1 shall be in accordance with generally accepted accounting and
- 2 reporting standards, except that management discussion and
- 3 analysis and related notes and the following financial-
- 4 statements shall not be required components of the annual
- 5 financial report: entity wide financial statements, including
- 6 the statement of activities and the statement of net assets; the
- 7 reconciliation of the balance sheet governmental funds to-
- 8 statement of net assets; and the reconciliation of the statement-
- 9 of revenues, expenditures and changes in fund balances -
- 10 governmental funds to statement of activities. The Department of
- 11 Education shall establish a reporting standard for the annual
- 12 financial report.
- (b) The chief school administrator and board secretary of a
- 14 school district, intermediate unit, charter school, cyber-
- 15 charter school or area vocational-technical school shall submit-
- 16 a signed statement to the Department of Education not later than-
- 17 the 31st day of December of each year certifying that: the
- 18 audited financial statements of the school district,
- 19 <u>intermediate unit</u>, charter school, cyber charter school or area
- 20 vocational-technical school have been properly audited pursuant-
- 21 to Article XXIV and that in the independent auditor's
- 22 professional opinion, the financial information submitted in the-
- 23 annual financial report was materially consistent with the-
- 24 audited financial statements.
- 25 (c) If the financial information submitted in the annual
- 26 financial report was not materially consistent with the audited
- 27 financial statements, the school district, intermediate unit,
- 28 charter school, cyber charter school or area vocational-
- 29 technical school shall submit a revised annual financial report-
- 30 to the Department of Education not later than the 31st day of

2	(d) The Department of Education shall order the forfeiture
3	penalties provided for under section 2552.1(a.1) against a
4	school district, intermediate unit, charter school, cyber
5	charter school or area vocational-technical school for failure
6	to timely submit an annual financial report or revised annual
7	financial report.
8	Section 2. Section 907 A of the act, added May 4, 1970
9	(P.L.311, No.102), is amended to read:
10	SECTION 1. SECTION 907-A OF THE ACT OF MARCH 10, 1949
11	(P.L.30, NO.14), KNOWN AS THE PUBLIC SCHOOL CODE OF 1949, ADDED
12	MAY 4, 1970 (P.L.311, NO.102), IS AMENDED TO READ:
13	Section 907-A. Subsidies for Services(a) Intermediate
14	units shall receive subsidies from the Commonwealth as herein
15	provided only for services performed pursuant to and authorized
16	by law, as hereinafter provided. Nothing contained herein shall
17	prohibit intermediate units from receiving funds from school
18	districts and other sources including nonpublic nonprofit
19	schools and expending such funds to provide additional services
20	not included in the approved program of services.
21	(b) No later than February 1, 2012, the intermediate units
22	AND BY FEBRUARY 1 OF EACH YEAR THEREAFTER, AN INTERMEDIATE UNIT
23	shall submit to the Department of Education a report on
24	subsidies and funds received in accordance with this section.
25	(1) The report shall include, but not be limited to, the
26	following information:
27	(i) A listing of all contracts, interagency

28 <u>agreements and purchase orders executed by a Commonwealth</u>
29 <u>agency with each intermediate unit AND BETWEEN</u>

30 <u>INTERMEDIATE UNITS.</u>

1	(ii) The total amount and duration of each item
2	under subparagraph (i), including the annual amount if
3	the item covers multiple years.
4	(iii) The source, or sources, and amounts of funds
5	needed to cover the entire cost of each item.
6	(iv) A description of programs or services, or both,
7	being provided, including performance measures by which
8	each intermediate unit will be assessed and penalties for
9	nonperformance, if any.
10	(v) A description of the selection process used in
11	entering into the arrangement.
12	(vi) A listing of all employes, contractors and
13	agents covered under the contracts, the duties of each
14	and the remuneration provided under the contract.
15	(2) The Department of Education shall develop the format
16	to be used by the intermediate units in the collection of the
17	information under paragraph (1).
18	(3) The Department of Education shall post the reports
19	on its Internet website.
20	(4) The first report shall cover fiscal year 2009 2010
21	YEARS 2009-2010 AND 2010-2011. EACH FUTURE REPORT SHALL COVER
22	THE PREVIOUS FISCAL YEAR.
23	Section $\frac{3}{2}$ 2. Section 921-A of the act is amended by adding a
24	subsection to read:
25	Section 921-A. Financial reports* * *
26	(a.1) The Department of Education shall post on its Internet
27	website, in the format consistent with those already posted for
28	the other local education agencies, information included in the
29	intermediate units' annual financial reports.
