SENATE BILL

No. 1124 Session of 2011

INTRODUCED BY CORMAN, JUNE 8, 2011

AS AMENDED ON SECOND CONSIDERATION, JUNE 26, 2011

A SUPPLEMENT

1 To the act of November 30, 1965 (P.L.843, No.355), entitled "An
2 act providing for the establishment and operation of Temple
3 University as an instrumentality of the Commonwealth to serve
4 as a State-related university in the higher education system
5 of the Commonwealth; providing for change of name; providing
6 for the composition of the board of trustees; terms of
7 trustees, and the power and duties of such trustees;
8 providing for preference to Pennsylvania residents in
9 tuition; providing for public support and capital
10 improvements; authorizing appropriations in amounts to be
11 fixed annually by the General Assembly; providing for the
12 auditing of accounts of expenditures from said
13 appropriations; authorizing the issuance of bonds exempt from
14 taxation within the Commonwealth; requiring the President to
15 make an annual report of the operations of Temple
16 University," making ~~appropriations~~ AN APPROPRIATION for ←
17 carrying the same into effect; providing for a basis for ←
18 payments of such ~~appropriations~~ APPROPRIATION; and providing ←
19 a method of accounting for the funds appropriated and for
20 certain fiscal information disclosure.

21 The General Assembly of the Commonwealth of Pennsylvania
22 hereby enacts as follows:

23 Section 1. The following sum, or as much thereof as may be
24 necessary, is hereby appropriated to the Trustees of Temple
25 University for the fiscal year July 1, 2011, to June 30, 2012,
26 for the purposes and in the amount as shown:

2 Section 2. Payments to Temple University on account of the
3 ~~appropriations for all items as~~ APPROPRIATION provided in
4 section 1 shall be made on the basis of costs during the fiscal
5 year.



6 Section 3. (a) Payment to Temple University of the
7 ~~appropriations~~ APPROPRIATION provided in section 1 shall be made
8 monthly during the fiscal year.



9 (b) Such monthly payments shall be made in accordance with
10 the provisions of section 2 on the basis of estimated costs. The
11 estimate of costs shall be submitted by Temple University to the
12 Secretary of Education, the General Assembly and the State
13 Treasurer not later than 30 days prior to the date on which such
14 payment is to be made.

15 Section 4. (a) Temple University shall apply the moneys
16 appropriated by this act only for such purposes as are permitted
17 in this act and shall at all times maintain proper records
18 showing the application of such moneys. Not later than 120 days
19 after the close of the fiscal year to which this act relates,
20 Temple University shall file, with the Secretary of Education,
21 the General Assembly and the Auditor General of the
22 Commonwealth, a statement setting forth the amounts and purposes
23 of all expenditures made from moneys appropriated by this act
24 and other university accounts during said fiscal year, as
25 provided in section 2, used as a basis for receipt of any
26 appropriation during said fiscal year.

27 (b) Such statement of expenditures and costs shall be
28 reviewed by the Auditor General of the Commonwealth, and he
29 shall have the right, in respect to the moneys appropriated by
30 this act, to audit and disallow expenditures made for purposes

1 not permitted by this act and to cause such sums to be recovered
2 and paid by Temple University to the State Treasurer. In respect
3 to expenditures made by the university from moneys other than
4 those appropriated by this act, the Auditor General shall have
5 the right to review only, and he shall file annually with the
6 General Assembly such information concerning said expenditures
7 as the General Assembly or any of its committees may require.

8 Section 5. Temple University shall provide full, complete
9 and accurate information as may be required by the Department of
10 Education or the chairman or the minority chairman of the
11 Appropriations Committee of the Senate or the chairman or the
12 minority chairman of the Appropriations Committee of the House
13 of Representatives.

14 Section 6. Temple University shall present and report its
15 financial statements required under the provisions of this act
16 in accordance with: the generally accepted accounting principles
17 as prescribed by the National Association of College and
18 University Business Officers, the American Institute of
19 Certified Public Accountants, or their successors, or by any
20 other recognized authoritative body; the "Commonwealth of
21 Pennsylvania Budget Instructions for the State System of Higher
22 Education, State-Related Universities and Non-State-Related
23 Colleges and Universities"; and the financial reporting policies
24 and standards promulgated by the Commonwealth of Pennsylvania
25 and by the Federal Government that apply to Temple University.

26 Section 7. This act shall take effect July 1, 2011, or
27 immediately, whichever is later.
