AN ACT

1 2 3	Establishing the Pennsylvania Long-term Care Council; providing for its powers and duties; and repealing related provisions of the Public Welfare Code.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Short title.
7	This act shall be known and may be cited as the Pennsylvania
8	Long-term Care Council Act.
9	Section 2. Definitions.
10	The following words and phrases when used in this act shall
11	have the meanings given to them in this section unless the
12	context clearly indicates otherwise:
13	"Council." The Pennsylvania Long-term Care Council.
14	"Department." The Department of Aging of the Commonwealth.
15	Section 3. Pennsylvania Long-term Care Council.
16	(a) EstablishmentThe Pennsylvania Long-term Care Council
17	is established within the department.
18	(b) MembershipThe council shall be composed of and

appointed in accordance with the following: 1 2 (1)The Secretary of Aging. 3 (2) The Secretary of Community and Economic Development. The Secretary of Health. 4 (3) 5 (4) The Secretary of Public Welfare. The Insurance Commissioner. 6 (5) 7 (6) The Executive Director of the Pennsylvania Housing 8 Finance Agency. 9 Two members of the House of Representatives, one (7)10 appointed by the Speaker of the House of Representatives and 11 one appointed by the Minority Leader. 12 (8) Two members of the Senate, one appointed by the 13 President pro tempore and one appointed by the Minority 14 Leader. 15 The following members to be recommended by the (9) 16 Secretary of Aging for appointment by the Governor as 17 follows: 18 (i) One representative from the Pennsylvania Council 19 on Aging. 20 (ii) Five members who represent consumer advocacy 21 groups. 22 (iii) One member who represents the elder law 23 section of the Pennsylvania Bar Association. 24 (iv) A licensed insurance producer with at least ten 25 years' experience in the long-term care insurance market 26 who is a member of an association through which members 27 sell, solicit and negotiate contracts of health 28 insurance. 29 (v) Five members who represent providers throughout 30 the long-term care continuum.

(vi) Four members of the public who represent
 business, labor, housing and the medical community, as
 the Governor shall appoint.

4 (c) Designee.--With the exception of the chairperson,
5 governmental members may appoint a designee to attend and vote
6 at meetings of the council. Each governmental member who
7 appoints a designee shall do so by sending a letter to the
8 chairperson stating the name of that designee.

9 (d) Chairperson.--The Secretary of Aging shall serve as10 chairperson.

11 (e) Executive director.--The Secretary of Aging shall12 appoint an executive director of the council.

13 (f) Terms of members.--

14 (1) The terms of those members who serve by virtue of 15 the public office they hold shall be concurrent with their 16 service in the office from which they derive their 17 membership.

18 (2) The remaining members shall serve until their
 19 successors are appointed, provided that they represent the
 20 interest of the membership class for which they were
 21 appointed.

(g) Expenses.--Members shall not receive compensation or remuneration, but shall be entitled to reimbursement for all reasonable and necessary actual expenses accrued in the performance of their duties as members.

26 Section 4. Powers and duties of council.

27 (a) General rule.--The council shall have the following28 powers and duties:

(1) To consult with various departments and agencies and
 to make recommendations on regulations, licensure, financing

or any other responsibilities of those departments or
 agencies relating to long-term care.

3 (2) To perform such other duties as the Governor may4 assign relating to long-term care.

5 (3) To approve reports produced by any committee
6 established under section 5 before release to the public or
7 the General Assembly.

8 (4) To develop and adopt rules for conducting council 9 meetings, including, but not limited to, the procedure for 10 formally adopting the approval of committee reports before 11 release to the public.

12 (5) To develop and adopt rules for conducting committee 13 meetings. This power includes, but is not limited to, 14 determining the scope of responsibilities for each committee, 15 the number of members for each committee and the procedure 16 for formally adopting the approval of committee reports 17 before release to the council.

18 (6) To assign topics for research and study to each 19 committee. Nothing in this paragraph shall be construed to 20 prohibit a committee from proposing topics for consideration 21 to the council.

(b) Scope.--All the powers and duties enumerated in this section shall be performed in a manner that addresses all areas of long-term care, including institutional care and home-based and community-based services.

26 Section 5. Council committees.

(a) Establishment.--The council shall establish committeesto address the following areas:

29 (1) Regulatory review and access to care.

30 (2) Community access and public education.

(3) Long-term care services models and delivery.

2 (4) Work force.

3 (b) Composition.--The council chairperson, with concurrence 4 by the council, shall appoint committee members to serve in the 5 same manner as section 3(f). The members shall represent:

6 (1) Advocacy groups.

7 (2) Consumers.

8 (3) Long-term care providers.

9 (4) Direct caregivers.

10 (5) The general public.

11 (6) Governmental entities.

12 (c) Chairpersons and vice chairpersons.--The chairperson of 13 the council shall appoint a chairperson and vice chairperson for 14 each committee.

15 (d) Duties.--The council committees shall have the following 16 powers and duties:

17 (1) To study and report on the topics assigned by the 18 council.

19 (2) To retain individuals, with the permission of the
20 council, to assist in researching, studying and drafting
21 reports for the council.

(3) To approve reports and recommendations for
submission to the council. Only members appointed to the
committee may participate in approving reports and
recommendations.

26 Nothing in this section shall be construed to prohibit the 27 chairperson, with concurrence by the council, from establishing 28 additional committees or ad hoc work groups to assist the 29 council of committees.

30 Section 6. Existing council members.

(2) Section 212 of the act of June 13, 1967 (P.L.31, 10 No.21), known as the Public Welfare Code, is repealed. 11 Section 8. Effective date. 12 This act shall take effect in six months. 13
