AN ACT

1 Amending Title 23 (Domestic Relations) of the Pennsylvania
2 Consolidated Statutes, in protection from abuse, further
3 providing for commencement of proceedings.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Section 6106 of Title 23 of the Pennsylvania
7 Consolidated Statutes is amended by adding a subsection to read:
8 § 6106. Commencement of proceedings.

10 (a.3) Notification regarding child abuse investigation.--

11 (1) If the plaintiff has knowledge of a ~~child abuse~~ <--

12 ~~investigation~~ FOUNDED OR INDICATED REPORT OF CHILD ABUSE <--

13 UNDER CHAPTER 63 (RELATING TO CHILD PROTECTIVE SERVICES)

14 involving the defendant, the petition shall include that

15 information together with the name of the investigative

16 agency.

1 (2) The petition shall include notice to the defendant
2 that an order issued under this chapter may have an impact on
3 the defendant under Chapter 63 ~~(relating to child protective~~ <--
4 ~~services)~~. The court shall develop procedures to implement
5 the provisions of this paragraph.

7 SECTION 2. THE ADDITION OF 23 PA.C.S. § 6106(A.3) SHALL <--
8 APPLY TO:

9 (1) AN ACTION UNDER 23 PA.C.S. CH. 61 FILED ON OR AFTER
10 THE EFFECTIVE DATE OF THIS ACT.

11 (2) A PETITION TO MODIFY OR EXTEND A PROTECTION FROM
12 ABUSE ORDER UNDER 23 PA.C.S. CH. 61 FILED ON OR AFTER THE
13 EFFECTIVE DATE OF THIS ACT.

14 Section ~~2~~ 3. This act shall take effect in 60 days. <--
