AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in State Board of Education, further 5 providing for membership and for powers and duties of the 6 7 board. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Sections 2602-B(a), (b), (e) and (f) and 2603-B(a) of the act of March 10, 1949 (P.L.30, No.14), known as the 11 Public School Code of 1949, added March 30, 1988 (P.L.321, 12 13 No.43), are amended to read: 14 Section 2602-B. Membership. -- (a) The board shall consist of [twenty-one (21)] fifteen (15) members, [ten (10)] seven (7) of 15 whom shall also serve as members of the Council of Basic 16 17 Education, and [ten (10)] seven (7) of whom shall also serve as 18 members of the Council of Higher Education. The member

designated by the Governor as chairman of the board shall also

service as a member of the Council of Basic Education and of the

- 1 Council of Higher Education. Except the legislative members,
- 2 each member shall be appointed by the Governor, by and with the
- 3 advice and consent of a majority of all the members of the
- 4 Senate, and shall, except as hereinafter provided, hold office
- 5 for terms of [six (6)] four (4) years each or until his
- 6 successor has been appointed and has qualified. An appointment
- 7 to fill a vacancy shall be for the unexpired term or until his
- 8 successor has been appointed and has qualified. The chairmen and
- 9 minority chairmen of the House of Representatives and Senate
- 10 Education Committees, or their respective designees from such
- 11 committees, shall serve as ex officio members of the board with
- 12 full voting privileges and shall serve as members for as long as
- 13 they hold their respective positions. The Chairman of the
- 14 Professional Standards and Practices Commission, or a commission
- 15 member designated by the chairman, created by the act of
- 16 December 12, 1973 (P.L.397, No.141), referred to as the Teacher
- 17 Certification Law, shall be an ex officio member of the board
- 18 without voting privileges or assignment to either council.
- 19 Members shall receive no salary but shall be entitled to travel
- 20 expenses and other necessary expenses incurred in the
- 21 performance of their duties as members of the board.
- 22 (b) [Eleven (11)] <u>Eight (8)</u> members shall constitute a
- 23 quorum provided that at least [five (5)] four (4) members
- 24 serving on each of the councils are present. The affirmative
- 25 vote of a majority of all the members of the board duly recorded
- 26 showing how each member voted shall be required in order to take
- 27 action adopting statements of policy, standards, rules and
- 28 regulations. The board shall meet at least six (6) times a year
- 29 at such times and places as it shall determine. Special meetings
- 30 may be called by the chairman or at the request of a majority of

- 1 the members of the board.

- 3 (e) For the purpose of formulating policy proposals
- 4 applicable to elementary, secondary, vocational-technical
- 5 education and higher education in this Commonwealth, there shall
- 6 be two councils, which shall consist of [ten (10)] seven (7)
- 7 members of the board each, the chairman being a member of both
- 8 councils, and shall be known as the Council of Basic Education
- 9 and the Council of Higher Education. The Governor shall
- 10 designate to serve at his pleasure a member serving on each
- 11 council to act as chairman of the council. Each council shall
- 12 meet at the call of its chairman or at the request of a majority
- 13 of the members of the council. The chairman of the board may
- 14 appoint special joint committees from among the members of the
- 15 board to formulate policy proposals in those areas which fall
- 16 within the purview of both of the councils.
- (f) (1) Except for the Secretary of Education, no member of
- 18 the board may be employed by the Department of Education.
- 19 <u>(2)</u> Except for the chairman, not more than two (2) members
- 20 serving on each council shall be employed [either] in a school
- 21 system [or in the Department of Education]. For purposes of this
- 22 [subsection] <u>clause</u>, the State System of Higher Education shall
- 23 not be considered a school system.
- 24 (3) Three (3) members of the Council of Higher Education
- 25 shall be actively employed by an institution of higher
- 26 education, at least one holding an administrative position and
- 27 at least one holding a professional position on a faculty of an
- 28 institution of higher education.
- 29 (4) At least two (2) members serving on each council shall
- 30 have had previous experience with vocational-technical education

- 1 or training.
- 2 (5) At least two (2) members of the Council of Basic
- 3 Education shall be a school director as provided for in Article
- 4 V, one of whom must be a resident of the western region of this
- 5 Commonwealth and one of whom must be a resident of the eastern
- 6 region of this Commonwealth.

- 8 Section 2603-B. Powers and Duties of the Board.--(a) (1)
- 9 The board shall have the power, and its duty shall be, to review
- 10 the statements of policy, standards, rules and regulations
- 11 formulated by the Council of Basic Education and the Council of
- 12 Higher Education, and adopt broad policies and principles, and
- 13 establish standards governing the educational program of the
- 14 Commonwealth.
- 15 (2) When adopting and establishing policies, principles and
- 16 standards, the board shall consider the economic impact and
- 17 costs of implementing the policies, principles and standards.
- 18 * * *
- 19 Section 2. This act shall take effect in 60 days.
