- Amending Title 18 (Crimes and Offenses) of the Pennsylvania
 - Consolidated Statutes, providing for the offense of criminal
- 3 surveillance.

- The General Assembly of the Commonwealth of Pennsylvania 4
- 5 hereby enacts as follows:
- 6 Section 1. Title 18 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- § 3505. Criminal surveillance. 8
- (a) Offense defined. -- A person commits the crime of criminal 9
- surveillance if he engages in surveillance while trespassing in 10
- 11 a private place.
- 12 (b) Separate violations. -- A separate violation of this
- 13 section shall occur:
- (1) for each victim of an offense under subsection (a) 14
- 15 under the same or similar circumstances pursuant to one

- 1 scheme or course of conduct whether at the same or different
- 2 time; or
- 3 (2) if a person is a victim of an offense under
- 4 <u>subsection (a) on more than one occasion during a separate</u>
- 5 <u>course of conduct either individually or otherwise.</u>
- 6 (c) Penalties.--
- 7 (1) A single violation of this section shall constitute
- 8 <u>a summary offense.</u>
- 9 (2) Multiple violations of this section shall constitute
- a misdemeanor of the third degree.
- 11 (d) Exceptions. -- Subsection (a) shall not apply if the
- 12 conduct proscribed under subsection (a) is done by any of the
- 13 <u>following:</u>
- (1) Law enforcement officers during a lawful criminal <--
- 15 <u>investigation</u> ENGAGED IN THE PERFORMANCE OF THEIR OFFICIAL <--
- 16 LAW ENFORCEMENT DUTIES.
- 17 (2) Law enforcement officers, personnel of the
- 18 Department of Corrections or a local correctional facility,
- 19 <u>prison or jail for security purposes or during investigation</u>
- of alleged misconduct by a person in the custody of the
- 21 <u>Department of Corrections or local authorities.</u>
- 22 (3) A person who is a passenger or pilot of an aircraft
- operating in a manner consistent with 74 Pa.C.S. § 5501
- 24 (relating to ownership of space).
- 25 (e) Definitions.--As used in this section, the following
- 26 words and phrases shall have the meanings given to them in this
- 27 <u>subsection unless the context clearly indicates otherwise:</u>
- 28 "Aircraft." The term as defined in 74 Pa.C.S. § 5102
- 29 (relating to definitions).
- 30 "LAW ENFORCEMENT OFFICER." ANY OFFICER OF THE UNITED STATES, <--

- 1 OF ANOTHER STATE OR SUBDIVISION THEREOF, OR OF THE COMMONWEALTH
- 2 OR POLITICAL SUBDIVISION THEREOF, WHO IS EMPOWERED BY LAW TO
- 3 CONDUCT INVESTIGATIONS OF OR TO MAKE ARRESTS FOR OFFENSES
- 4 ENUMERATED IN THIS TITLE OR AN EQUIVALENT CRIME IN ANOTHER
- 5 JURISDICTION AND ANY ATTORNEY AUTHORIZED BY LAW TO PROSECUTE OR
- 6 PARTICIPATE IN THE PROSECUTION OF SUCH OFFENSE.
- 7 "Private place." A place where a person may reasonably
- 8 <u>expect to be safe from casual or hostile intrusion or</u>
- 9 surveillance.
- 10 "Surveillance." Observation of the activities of another
- 11 person or invading the privacy of the person observed.
- 12 <u>"Trespassing." Entering or remaining, or causing any</u>
- 13 <u>instrument or device equipped with technology to facilitate</u>
- 14 surveillance to enter or remain, on the land or in the airspace
- 15 of another, by one who knows he is not authorized or privileged
- 16 <u>to do so.</u>
- 17 Section 2. This act shall take effect in 90 days.
