## AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing 5 for tax credits in certain cases; conferring powers and imposing duties upon the Department of Revenue, certain 7 employers, fiduciaries, individuals, persons, corporations and other entities; prescribing crimes, offenses and 9 penalties," in realty transfer tax, further providing for 10 definitions and for excluded transactions. 11
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Section 1101-C of the act of March 4, 1971
- 15 (P.L.6, No.2), known as the Tax Reform Code of 1971, is amended
- 16 by adding definitions to read:
- 17 Section 1101-C. Definitions.--The following words when used

- 11 Section 2. Section 1102-C.3 of the act is amended by adding
- 12 a clause to read:
- 13 Section 1102-C.3. Excluded Transactions. -- The tax imposed by
- 14 section 1102-C shall not be imposed upon:

- 16 (23) A transfer of real estate:
- 17 (i) for no or nominal consideration from the Commonwealth or
- 18 any of its instrumentalities, agencies or political subdivisions
- 19 to a volunteer emergency medical services agency, volunteer fire
- 20 company or volunteer rescue company; or
- 21 (ii) between two or more volunteer emergency medical
- 22 <u>services agencies</u>, volunteer fire companies or volunteer rescue
- 23 companies.
- 24 Section 3. The addition of section 1102-C.3(23) of the act
- 25 shall apply to transactions occurring on or after the effective <--
- 26 date of this section NOVEMBER 1, 2011.
- 27 Section 4. This act shall take effect immediately.
