AN ACT

- Providing for the Early Childhood Vision Care Education Program and for powers and duties of the Department of Health.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Early
- 7 Childhood Vision Care Education Act.
- 8 Section 2. Findings.
- 9 The General Assembly finds and declares as follows:
- 10 (1) The National Institute of Health reports that many
- 11 vision problems develop before children reach school age.
- 12 (2) According to the Centers for Disease Control, less
- than 15% of all preschool children receive an eye exam and
- 14 less than 22% of preschool children receive some type of
- 15 vision screening.
- 16 (3) Every effort must be made to ensure that, before
- they reach five years of age, children receive a screening

- 1 exam from their health care provider.
- 2 (4) Early recognition of vision disorders and eye
- 3 disease results in more effective treatment that can be sight
- 4 saving or even lifesaving.
- 5 (5) The most common disabling childhood vision disorders
- 6 include amblyopia, strabismus and significant refractive
- 7 errors.
- 8 (6) Retinoblastoma, which can be detected in a routine
- 9 eye examination, is the most common type of eye tumor in
- 10 children and is the seventh most common pediatric cancer.
- 11 (7) Children born with retinoblastoma are rarely
- diagnosed at birth, with the average age of diagnosis at two
- 13 years of age.
- 14 (8) Ninety-five percent of all cases of retinoblastoma
- occur in children under five years of age.
- 16 (9) Untreated, retinoblastoma is almost always fatal,
- 17 however, early diagnosis and treatment saves lives and
- 18 preserves visual function.
- 19 Section 3. Definitions.
- The following words and phrases when used in this act shall
- 21 have the meanings given to them in this section unless the
- 22 context clearly indicates otherwise:
- 23 "Amblyopia." The loss of one eye's ability to see details.
- 24 "Department." The Department of Health of the Commonwealth.
- 25 "Retinoblastoma." A cancer of one or both eyes which occurs
- 26 in young children.
- 27 "Strabismus." A disorder in which the two eyes do not line
- 28 up in the same direction and therefore do not look at the same
- 29 object at the same time.
- 30 Section 4. Early Childhood Vision Care Education Program.

- 1 (a) Establishment. -- The department shall establish the Early
- 2 Childhood Vision Care Education Program to promote public
- 3 awareness of the need for vision care for young children and the
- 4 value of early detection, diagnosis and treatment of vision
- 5 disorders and eye diseases.
- 6 (b) Duties of department. -- The department shall:
- 7 (1) Establish a public education and outreach campaign
- 8 via written materials and brochures to promote the importance
- 9 of vision examination for young children and awareness of
- 10 vision disorders and eye diseases, including amblyopia,
- 11 strabismus and retinoblastoma.
- 12 (2) Develop educational materials and brochures and make
- them available to parents through State and local departments
- of health, hospitals, clinics, health care providers,
- preschool programs, child-care providers and early childhood
- 16 programs.
- 17 (3) Develop relationships with health care providers and
- 18 health-related community-based organizations to promote and
- 19 coordinate public education programs on early childhood
- 20 vision care.
- 21 Section 5. Grant acceptance.
- The department may accept grants, services and property from
- 23 the Federal Government, foundations, organizations and other
- 24 entities as may be available to carry out the provisions of this
- 25 act.
- 26 Section 6. Effective date.
- 27 This act shall take effect in 60 days.
