1	Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as
2	reenacted, "An act relating to alcoholic liquors, alcohol and
3	malt and brewed beverages; amending, revising, consolidating
4	and changing the laws relating thereto; regulating and
5	restricting the manufacture, purchase, sale, possession,
6	consumption, importation, transportation, furnishing, holding
7	in bond, holding in storage, traffic in and use of alcoholic

24	Section 408.12. Wine Auction Permits(a) Upon application

1 (1) any nonprofit hospital;

2 any nonprofit public television station which is a (2) 3 member of the Pennsylvania Public Television Network; any orchestra located in a county of the first, second 4 (3) or third class which is operated by a nonprofit corporation; 5 any museum located in a county of the first, second or 6 (4) 7 third class which is operated by a nonprofit corporation; 8 (5) any nonprofit corporation located in any county of the third class which trains and places dogs for people who are 9

10 physically handicapped;

11 (6) any nationally recognized community-based voluntary 12 health organization committed to fighting cancer which has been 13 in existence for at least ninety years;

14 (7) any nationally recognized emergency response 15 organization that offers humanitarian care to victims of war or 16 natural disaster and has been in existence for at least one 17 hundred twenty-five years;

(8) any nationally recognized organization whose purpose is to serve as an agent to collect funds for local charities, as well as to coordinate relief services, counsel and refer clients to cooperating agencies and make emergency assistance grants and has been in existence for at least one hundred twenty years; [or]

(9) any hospice as defined under section 802.1 of the act of July 19, 1979 (P.L.130, No.48), known as the "Health Care Facilities Act"; or
