AN ACT

- Amending the act of August 26, 1971 (P.L.351, No.91), entitled
- "An act providing for a State Lottery and administration
- thereof; authorizing the creation of a State Lottery 3
- Commission; prescribing its powers and duties; disposition of 4
- funds; violations and penalties therefor; exemption of prizes
- from State and local taxation and making an appropriation," 6
- in State lottery, providing for disposition of funds in 7
- fiscal year 2013-2014.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. The act of August 26, 1971 (P.L.351, No.91),
- 12 known as the State Lottery Law, is amended by adding a section
- 13 to read:
- Section 311.1. Disposition of funds in fiscal year 2013-2014. 14

- 1 (a) Establishment of account. -- A restricted reserve account
- 2 is established in the State Lottery Fund. The moneys of the
- 3 account are hereby appropriated on a continuing basis to carry
- 4 <u>out the provisions of this section.</u>
- 5 (b) Initial transfer of moneys into account. -- Within ten
- 6 days of the effective date of this section, an amount equal to
- 7 the difference between the aggregate increase for fiscal year
- 8 <u>2013-2014</u> and the aggregate increase for fiscal year 2012-2013
- 9 shall be transferred from available funds in the State Lottery
- 10 Fund to the account.
- 11 (c) Distribution of moneys from account. -- Subject to the
- 12 provisions of subsection (d), during the fiscal year 2013-2014,
- 13 the moneys in the account shall be expended on programs for
- 14 <u>seniors on a pro rata basis, based on the distribution of funds</u>
- 15 to programs for seniors in the Governor's Executive Budget for
- 16 <u>fiscal year 2013-2014</u>, except that the funds for medical
- 17 assistance long-term care and for the Pharmaceutical Assistance
- 18 Contract for the Elderly shall not be part of this calculation.
- 19 (d) Hold harmless transfer of moneys into account.--After
- 20 the transfer of moneys into the account under subsection (b) and
- 21 enactment of a general appropriations act for the fiscal year
- 22 2013-2014, if any of the programs for seniors receive, excluding
- 23 the distribution required under subsection (c), less funding
- 24 from the State Lottery Fund in fiscal year 2013-2014 than was
- 25 received in fiscal year 2012-2013, then the Secretary of Revenue
- 26 shall transfer from the State Lottery Fund to the account an
- 27 amount necessary to insure that any of such programs for seniors
- 28 receive the same amount of funding from the State Lottery Fund
- 29 as was proposed for the programs for seniors in the Governor's
- 30 Executive Budget for fiscal year 2013-2014. Moneys transferred

- 1 under this subsection shall be distributed in the same manner as
- 2 provided in subsection (c).
- 3 (e) Definitions.--As used in this section, the following
- 4 words and phrases shall have the meanings given to them in this
- 5 <u>subsection unless the context clearly indicates otherwise:</u>
- 6 "Account." The restricted reserve account established by
- 7 this section.
- 8 "Aggregate increase for fiscal year 2012-2013." The
- 9 <u>difference between the aggregate dollar amount expended from the</u>
- 10 State Lottery Fund through appropriations and executive
- 11 authorizations relating to programs for seniors in fiscal years
- 12 <u>2012-2013</u> and 2011-2012.
- 13 <u>"Aggregate increase for fiscal year 2013-2014." The</u>
- 14 difference between the aggregate dollar amount expended from the
- 15 State Lottery Fund through appropriations and executive
- 16 authorizations relating to programs for seniors in fiscal year
- 17 2012-2013 and the Governor's Executive Budget for fiscal year
- 18 2013-2014.
- 19 "Programs for seniors." The programs or grants for the
- 20 benefit of seniors that are funded through the State Lottery
- 21 Fund in the Governor's Executive Budget for fiscal year 2013-
- 22 2014. The term does not include:
- 23 (1) Funds for prizes to the holders of winning lottery
- tickets or shares.
- 25 (2) Funds for administrative or operating expenses for
- the lottery, including general government operations or
- 27 expenses of any private contractor, advertising expenses or
- 28 commissions.
- 29 Section 2. This act shall take effect July 1, 2013, or
- 30 immediately, whichever is later.
