AN ACT

4 THE GENERAL ASSEMBLY FINDS AND DECLARES AS FOLLOWS: <--

5 (1) IT IS THE PURPOSE OF THIS ACT TO REFORM AND
6 MODERNIZE THE SYSTEM BY WHICH ALCOHOL IS DISPENSED AND
7 CONTROLLED WITHIN THIS COMMONWEALTH TO REFLECT CHANGES IN THE
8 MARKETPLACE WHILE CONTINUING TO PROTECT THE WELFARE, HEALTH,
9 PEACE AND MORALS OF THE CITIZENS OF THIS COMMONWEALTH.

10 (2) THE 21ST AMENDMENT TO THE UNITED STATES CONSTITUTION
11 DICTATES THAT THE LAWS OF THE STATES SHALL GOVERN THE
12 TRANSPORTATION AND IMPORTATION OF INTOXICATING LIQUORS INTO
13 THE STATE FOR DELIVERY AND USE WITHIN THE STATE.

14 (3) FURTHER, THE UNITED STATES SUPREME COURT HAS OPINED
15 IN INTERPRETING THE 21ST AMENDMENT THAT "THE STATES'
16 REGULATORY POWER OVER THIS SEGMENT OF COMMERCE IS LARGELY
17 UNFETTERED BY THE CONSTITUTION'S COMMERCE CLAUSE."

18 (4) REVENUES DERIVED FROM THE OPERATION OF A SYSTEM FOR
19 THE MANUFACTURE, TRANSPORTATION, DISTRIBUTION AND SALE OF
20 ALCOHOL ARE NECESSARY TO IMPLEMENT AND SUSTAIN A REGULATED
21 MARKETPLACE TO CONTINUE TO PROTECT THE WELFARE, HEALTH, PEACE
22 AND MORALS OF THE CITIZENS OF THIS COMMONWEALTH AND TO
23 CONTRIBUTE TO THE OVERALL ECONOMIC STABILITY OF THE
24 COMMONWEALTH.

25 (5) IN ORDER TO ADAPT TO THE CHANGING MARKETPLACE, THIS
26 ACT WILL:

27 (I) PERMIT PRIVATE INDUSTRY TO OFFER ADDITIONAL
28 PRODUCTS FOR SALE WHILE ENSURING THAT THE LAWS OF THIS
29 COMMONWEALTH ARE THOROUGHLY ENFORCED.

30 (II) ENSURE THAT THE VALUE OF LICENSES HELD BY SMALL
31 BUSINESSES ARE NOT DEVALUED, BUT ARE ENHANCED THROUGH THE

1 OPPORTUNITY TO EXPAND OPERATIONS AND SALES.

2 (III) PROVIDE FOR THE OPERATION OF A RETAIL SYSTEM
3 THAT PROMOTES COMPETITION AND CONVENIENCE TO ENSURE THAT
4 THE RESIDENTS OF THIS COMMONWEALTH PURCHASE PRODUCTS
5 WITHIN THIS COMMONWEALTH.

6 (IV) IN RECOGNITION OF THE GROWING USE OF E-COMMERCE
7 SALES, PERMIT CONSUMERS TO PURCHASE PRODUCTS ONLINE AND
8 HAVE THOSE PRODUCTS SHIPPED DIRECTLY TO THEM.

9 (V) ESTABLISH A SYSTEM BY WHICH THESE INCREASED
10 OPPORTUNITIES WILL CONTINUE TO CONTRIBUTE TO OVERALL
11 FISCAL STABILITY OF THE COMMONWEALTH.

12 (6) RECOGNITION AND FURTHERANCE OF ALL THESE ELEMENTS IS
13 ESSENTIAL TO THE WELFARE, HEALTH, PEACE AND MORALS OF THE
14 CITIZENS OF THIS COMMONWEALTH.

15 The General Assembly of the Commonwealth of Pennsylvania
16 hereby enacts as follows:

7 ~~a person or group of persons acting in concert of more than~~
8 ~~twenty per centum of a licensee's securities or other ownership~~
9 ~~interests, with the exception of any ownership interest of the~~
10 ~~person that existed at the time of initial licensing, or more~~
11 ~~than twenty per centum of the securities or other ownership~~
12 ~~interests of a corporation or other legal entity which owns,~~
13 ~~directly or indirectly, at least twenty per centum of the~~
14 ~~securities or other ownership interests of the licensee.~~

16 ~~"Growler" shall mean a refillable glass container that holds~~
17 ~~a minimum of sixty four fluid ounces for malt or brewed~~

21 ~~stores, as determined by the board, located in any given county~~

5 ~~one licensee as compared to the price of the same item to~~
6 ~~another licensee or a licensee of a different classification.~~
7 ~~The term shall not include discounts for volume purchases.~~

9 ~~"Wholesale acquisition factor" shall mean a factor of 2.5~~
10 ~~applied to the wholesale profit margin of a brand of liquor in~~
11 ~~determining a wholesale license fee.~~

12 ~~"Wholesale licensee" shall mean a person that holds a wine~~
13 ~~and spirits wholesale license issued pursuant to section~~
14 ~~321.1 A.~~

15 ~~"Wholesale profit margin" shall mean, for any particular~~
16 ~~liquor product, twenty per centum of the total of costs of goods~~
17 ~~sold of the product in the Commonwealth over the most recent 12~~
18 ~~month period for which information is available.~~

20 ~~"Wine and spirits retail license" shall mean a license issued~~
21 ~~by the department or the board authorizing a person to sell and~~
22 ~~distribute wine and spirits to the public for off the premises~~

25 ~~issued by the department or the board authorizing a person to~~

15 AUTHORIZED TO STORE AND REPACKAGE MALT OR BREWED BEVERAGES OWNED
16 BY A MANUFACTURER AT A SEGREGATED PORTION OF A WAREHOUSE OR
17 OTHER STORAGE FACILITY AUTHORIZED BY SECTION 441(D) AND OPERATED

23 OR DELIVERY SERVICES. IN THE CASE OF A BAILEE FOR HIRE HIRED BY

2 OR IMPORTING DISTRIBUTOR AS THE PRIMARY OR ORIGINAL SUPPLIER OF
3 HIS PRODUCT, HE SHALL ALSO DESIGNATE THE SPECIFIC GEOGRAPHICAL
4 AREA FOR WHICH THE SAID DISTRIBUTOR OR IMPORTING DISTRIBUTOR IS
5 GIVEN DISTRIBUTING RIGHTS, AND SUCH DISTRIBUTOR OR IMPORTING
6 DISTRIBUTOR SHALL NOT SELL OR DELIVER THE PRODUCTS OF SUCH

2 BEVERAGES AND THE AMOUNT OF CAPITAL EXPENDITURES MADE BY THE
3 TAXPAYER AT EACH LOCATION OPERATED BY THE TAXPAYER OR A PARENT
4 CORPORATION, SUBSIDIARY, JOINT VENTURE OR AFFILIATE. THE
5 TAXPAYER SHALL NOTIFY THE SECRETARY OF ANY CONTRACT FOR
6 PRODUCTION HELD WITH ANOTHER MANUFACTURER. THE SECRETARY SHALL
7 FILE A REPORT ANNUALLY WITH THE CHIEF CLERK OF THE HOUSE OF
8 REPRESENTATIVES AND WITH THE SECRETARY OF THE SENATE OUTLINING
9 THE EMPLOYMENT, PRODUCTION, EXPENDITURES AND TAX CREDITS
10 AUTHORIZED UNDER THIS SECTION.

11 (C) UPON RECEIPT FROM A TAXPAYER OF A CERTIFICATE FROM THE
12 SECRETARY ISSUED UNDER SUBSECTION (A), THE SECRETARY SHALL GRANT
13 A TAX CREDIT OR CREDITS IN THE AMOUNT CERTIFIED AGAINST ANY TAX
14 DUE UNDER ARTICLE XX OF THE ACT OF MARCH 4, 1971 (P.L.6, NO.2),
15 KNOWN AS THE "TAX REFORM CODE OF 1971," IN THE CALENDAR YEAR IN
16 WHICH THE EXPENDITURES WERE INCURRED OR AGAINST ANY TAX BECOMING

20 BEFORE JANUARY 1, 2013, AND NO TAXPAYER SHALL BE ELIGIBLE TO
21 RECEIVE A TAX CREDIT FOR A QUALIFYING EXPENDITURE MADE ON OR
22 BEFORE DECEMBER 31, 2009.

23 (D) (1) AS USED IN THIS SECTION, THE FOLLOWING WORDS AND
24 PHRASES SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS SUBSECTION
25 UNLESS THE CONTEXT CLEARLY INDICATES OTHERWISE:

26 "AMOUNTS PAID." THE PHRASE MEANS:

27 (I) AMOUNTS ACTUALLY PAID; OR

28 (II) AT THE TAXPAYER'S ELECTION, AMOUNTS PROMISED TO BE PAID
29 UNDER FIRM PURCHASE CONTRACTS ACTUALLY EXECUTED DURING ANY
30 CALENDAR YEAR: PROVIDED, HOWEVER, THAT THERE SHALL BE NO

1 DUPLICATION OF "AMOUNTS PAID" UNDER THIS DEFINITION.
2 "QUALIFYING CAPITAL EXPENDITURES." AMOUNTS PAID BY A
3 TAXPAYER FOR THE PURCHASE OF ITEMS OF PLANT, MACHINERY OR
4 EQUIPMENT FOR USE BY THE TAXPAYER WITHIN THIS COMMONWEALTH IN
5 THE MANUFACTURE AND SALE OF MALT OR BREWED BEVERAGES: PROVIDED,
6 HOWEVER, THAT THE TOTAL AMOUNT OF QUALIFYING CAPITAL

18 SECTION 28. STUDIES OF THE WINE AND SPIRITS WHOLESALE SYSTEM
19 IN THIS COMMONWEALTH SHALL BE CONDUCTED AS FOLLOWS:

15 EACH INDIVIDUAL COUNTY IS MEETING CONSUMER DEMAND.

16 (2) THE PENNSYLVANIA LIQUOR CONTROL BOARD SHALL CONDUCT
17 A STUDY OF THE WINE AND SPIRITS WHOLESALE SYSTEM IN THIS
18 COMMONWEALTH. THE STUDY SHALL COMMENCE SEPTEMBER 1, 2015, AND
19 SHALL BE PRESENTED TO THE CHAIRMAN AND MINORITY CHAIRMAN OF

6 CONTAINED IN THIS ACT AND PROVIDE RECOMMENDATIONS TO

8 (VI) PROVIDE A VALUATION OF THE WINE AND SPIRITS
9 WHOLESALE AND RETAIL SYSTEMS.

10 (VII) DETERMINE WHETHER THE CURRENT QUOTA SYSTEM IN <--
11 EACH INDIVIDUAL COUNTY IS MEETING CONSUMER DEMAND.

12 (3) IF THE FINDINGS OF EITHER STUDY DETERMINE THAT THE
13 DIVESTITURE OF THE WINE AND SPIRITS WHOLESALE SYSTEM WOULD
14 NOT HAVE A SIGNIFICANT IMPACT ON THE ANNUAL FISCAL STABILITY
15 OF THE COMMONWEALTH, THE GENERAL ASSEMBLY MAY CONSIDER
16 LEGISLATION PROVIDING FOR THE DIVESTITURE OF THE WINE AND
17 SPIRITS WHOLESALE SYSTEM. FOLLOWING THE GENERAL ASSEMBLY'S
