AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in school health services, providing
- for school access to emergency epinephrine. 6
- The General Assembly of the Commonwealth of Pennsylvania 7
- hereby enacts as follows: 8
- Section 1. The act of March 10, 1949 (P.L.30, No.14), known 9
- 10 as the Public School Code of 1949, is amended by adding a
- section to read: 11
- 12 Section 1414.2. School Access to Emergency Epinephrine. -- (a)
- 1.3 Subject to subsection (q), a school entity or nonpublic school
- 14 may authorize a trained school employe to:
- 15 (1) provide an epinephrine auto-injector that meets the
- prescription on file for either the individual student or the 16
- school entity or nonpublic school to a student who is authorized 17

- 1 to self-administer an epinephrine auto-injector;
- 2 (2) administer to a student an epinephrine auto-injector
- 3 that meets the prescription on file for either the individual
- 4 <u>student or the school entity or nonpublic school; and</u>
- 5 (3) administer an epinephrine auto-injector that meets the
- 6 prescription on file for the school entity or nonpublic school
- 7 to a student that the employe in good faith believes to be
- 8 <u>having an anaphylactic reaction.</u>
- 9 (b) Notwithstanding section 11 of the act of April 14, 1972
- 10 (P.L.233, No.64), known as "The Controlled Substance, Drug,
- 11 <u>Device and Cosmetic Act," a physician OR CERTIFIED REGISTERED</u> <
- 12 NURSE PRACTITIONER may prescribe epinephrine auto-injectors in
- 13 the name of the school entity or nonpublic school to be
- 14 maintained for use pursuant to subsection (a).
- 15 (c) A school entity or nonpublic school may maintain at a
- 16 school in a locked SAFE, secure location a supply of epinephrine <--
- 17 auto-injectors.
- 18 (d) A school entity or nonpublic school that authorizes the
- 19 provision of epinephrine auto-injectors under this section shall
- 20 designate one or more individuals at each school who shall be
- 21 responsible for the storage and use of the epinephrine auto-
- 22 injectors.
- 23 (e) Individuals who are responsible for the storage and use
- 24 of epinephrine auto-injectors must successfully complete a
- 25 training program that shall be developed and implemented by the
- 26 Department of Health within ninety (90) days of the effective
- 27 <u>date of this section</u>.
- 28 (f) (1) An epinephrine auto-injector from the school
- 29 entity's or nonpublic school's supply of epinephrine auto-
- 30 injectors that meets the prescription on file for the school

- 1 entity or nonpublic school may be provided to and utilized by a
- 2 <u>student authorized to self-administer or may be administered by</u>
- 3 <u>a trained school employe authorized to administer an epinephrine</u>
- 4 <u>auto-injector to a student pursuant to subsection (a).</u>
- 5 (2) When a student does not have an epinephrine auto-
- 6 <u>injector or a prescription for an epinephrine auto-injector on</u>
- 7 <u>file, a trained school employe may utilize the school entity's</u>
- 8 or nonpublic school's supply of epinephrine auto-injectors to
- 9 respond to anaphylactic reaction under a standing protocol from
- 10 a physician OR CERTIFIED REGISTERED NURSE PRACTITIONER and as
- 11 provided in this section.
- 12 (f.1) In the event a student is believed to be having an
- 13 <u>anaphylactic reaction</u>, the school nurse or an individual in the
- 14 school who is responsible for the storage and use of epinephrine
- 15 auto-injectors shall contact 911 as soon as possible.
- 16 (g) At the request of a parent or legal quardian, a student
- 17 shall be exempt from subsections (a), (f) and (h). The principal
- 18 of the school in which the student is enrolled shall notify all
- 19 parents or legal quardians of their ability to exempt their
- 20 children from subsections (a), (f) and (h) by returning a signed
- 21 opt-out form.
- 22 (h) The provisions of 42 Pa.C.S. §§ 8332 (relating to
- 23 emergency response provider and bystander good Samaritan civil
- 24 immunity) and 8337.1 (relating to civil immunity of school
- 25 officers or employees relating to emergency care, first aid and
- 26 rescue) shall apply to a person who administers an epinephrine
- 27 <u>auto-injector pursuant to this section.</u>
- 28 (i) Administration of an epinephrine auto-injector under
- 29 this section shall comply with section 504 of the Rehabilitation
- 30 Act of 1973 (Public Law 93-112, 29 U.S.C. § 794) and 22 Pa. Code

- 1 Ch. 15 (relating to protected handicapped students).
- 2 (j) As used in this section, "school entity" means a school
- 3 <u>district</u>, <u>intermediate unit</u>, <u>charter school</u>, <u>cyber charter</u>
- 4 <u>school</u>, <u>regional charter school or area vocational-technical</u>
- 5 school.
- 6 Section 2. This act shall take effect in 60 days.
