AN ACT

- 1 Amending Titles 18 (Crimes and Offenses) and 23 (Domestic
- 2 Relations) of the Pennsylvania Consolidated Statutes, further
- 3 providing for protective custody of newborn children in the
- areas of criminal liability, child protective services and
- 5 newborn protection.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 4306(a) introductory paragraph and (1)
- 9 and (b) of Title 18 of the Pennsylvania Consolidated Statutes
- 10 are amended to read:
- 11 § 4306. Newborn protection.
- 12 (a) General rule. -- A parent of a newborn shall not be
- 13 criminally liable for any violation of this title solely for
- 14 leaving a newborn [in the care of a hospital] pursuant to 23
- 15 Pa.C.S. Ch. 65 (relating to newborn protection) providing that
- 16 the following criteria are met:

- 1 (1) The parent expresses, either orally or through
- 2 conduct, the intent to have the hospital or police station
- accept the newborn pursuant to 23 Pa.C.S. Ch. 65.
- 4 * * *
- 5 (b) Definition.--As used in this section, the [term
- 6 "newborn" shall have the meaning given to it in 23 Pa.C.S. §
- 7 6502 (relating to definitions) and "child abuse" shall be as]
- 8 following words and phrases shall have the meanings given to
- 9 them in this subsection unless the context clearly indicates
- 10 otherwise:
- "Child abuse." As defined in 23 Pa.C.S. § 6303(b) (relating
- 12 to definitions).
- "Newborn." As defined in 23 Pa.C.S. § 6502 (relating to

- 18 (a) General rule. -- The following words and phrases when used
- 19 in this chapter shall have the meanings given to them in this
- 20 section unless the context clearly indicates otherwise:

- 22 "Police officer." A law enforcement member of the
- 23 Pennsylvania State Police or a municipal police force.

- 25 Section 3. Section 6315(a) of Title 23 is amended by adding
- 26 a paragraph to read:
- 27 § 6315. Taking child into protective custody.
- 28 (a) General rule. -- A child may be taken into protective
- 29 custody:
- 30 * * *

- 1 (4) By a police officer at a police station under
- 2 Chapter 65.
- 3 * * *
- 4 Section 4. Section 6316(a.1) of Title 23 is amended to read:
- 5 § 6316. Admission to private and public hospitals.
- 6 * * *
- 7 (a.1) Newborns. -- A newborn taken into protective custody
- 8 pursuant to section 6315(a)(3) or (4) (relating to taking child
- 9 into protective custody) shall be admitted to, treated and
- 10 maintained in facilities of public and private hospitals on the
- 11 basis of medical need and shall not be refused or deprived in
- 12 any way of proper medical treatment and care. Once a newborn is
- 13 taken into protective custody pursuant to section 6315(a)(3) or
- 14 (4), the newborn shall be considered immediately eligible for
- 15 Medicaid for payment of medical services provided. Until
- 16 otherwise provided by court order, the county agency shall
- 17 assume the responsibility for making decisions regarding the
- 18 newborn's medical care.

- "Health care provider." A person who is licensed or

- 30 care in the ordinary course of business or practice of a

- 2 section 6504(a)(1) (relating to accepting newborns) and for
- 3 immunity provided pursuant to section 6507 (relating to immunity
- 4 [granted to health care providers and hospitals]), the term
- 5 includes administrative, managerial and security personnel and
- 6 any other person employed by a hospital.

- 8 <u>"Police officer." A law enforcement member of the</u>
- 9 <u>Pennsylvania State Police or a municipal police force.</u>
- 10 Section 6. Section 6504(a)(1) and (b) of Title 23 are
- 11 amended to read:
- 12 § 6504. Accepting newborns.
- 13 (a) General rule. -- A health care provider at a hospital
- 14 shall do all of the following relating to a newborn accepted
- 15 under this chapter:
- 16 (1) Take the newborn into protective custody as provided
- in section 6315(a)(3) (relating to taking child into
- 18 protective custody) or 6504.1(a)(2) (relating to accepting
- 19 newborns by uniformed police officer at police station).
- 20 * * *
- 21 (b) Accepting newborns.--When [accepting] a health care
- 22 provider accepts a newborn pursuant to this chapter, a parent or
- 23 <u>uniformed police officer</u> may provide a health care provider with
- 24 information about the newborn's medical history and any
- 25 identifying information.
- Section 7. Title 23 is amended by adding a section to read:
- 27 § 6504.1. Accepting newborns by uniformed police officer at
- police station.
- 29 <u>(a) Duties.--A uniformed police officer at a police station</u>
- 30 shall do all of the following relating to a newborn accepted

- 1 <u>under this chapter:</u>
- 2 (1) Take the newborn into protective custody under
- 3 section 6315(a)(4) (relating to taking child into protective
- 4 <u>custody</u>).
- 5 (2) Take the newborn to the hospital and place into the
- 6 <u>care of a health care provider under section 6504 (relating</u>
- 7 to accepting newborns).
- 8 (3) Notify the county agency under section 6505
- 9 <u>(relating to reporting acceptance of newborns).</u>
- 10 (b) Information. -- When a uniformed police officer accepts a
- 11 newborn pursuant to this chapter, a parent may provide the
- 12 <u>uniformed police officer with information about the newborn's</u>
- 13 medical history and any identifying information.
- 14 Section 8. Sections 6505, 6507 and 6509 of Title 23 are
- 15 amended to read:
- 16 § 6505. Reporting acceptance of newborns.
- 17 [A] (a) Health care providers.--Unless subsection (b)
- 18 applies, a health care provider at a hospital shall [in all
- 19 cases] notify the county agency and the local municipal police
- 20 department or the Pennsylvania State Police where no municipal
- 21 police jurisdiction exists immediately by telephone regarding a
- 22 newborn accepted by a hospital under this chapter. [A] <u>Unless</u>
- 23 <u>subsection (b) applies, a</u> written report shall be submitted to
- 24 the county agency and local municipal police department or the
- 25 Pennsylvania State Police within 48 hours after the oral report.
- 26 [For purposes of]
- 27 (b) Uniformed police officers.--A police officer acting
- 28 under section 6504.1 (relating to accepting newborns by
- 29 <u>uniformed police officer at police station</u>) shall:
- 30 (1) notify the county agency by telephone regarding a

- 1 <u>newborn accepted by an officer under this chapter; and</u>
- 2 (2) submit a written report to the county agency and the
- 3 officer's police department within 48 hours after
- 4 <u>notification under paragraph (1).</u>
- 5 <u>(c) Definition.--As used in</u> this section, the term "health
- 6 care provider" [shall include] includes administrative,
- 7 managerial and security personnel employed by a hospital.
- 8 § 6507. Immunity [granted to health care providers and
- 9 hospitals].
- 10 Except for a violation of section 6506 (relating to failure
- 11 to report acceptance of newborns), no hospital [or] $_{\boldsymbol{L}}$ health care
- 12 provider at a hospital or police officer shall be subject to
- 13 civil liability or criminal penalty solely by reason of
- 14 complying with the provisions of this chapter.
- 15 § 6509. Duties of department.
- 16 The department shall provide educational materials for use by
- 17 hospitals, health care providers [and] _ employees at hospitals
- 18 <u>and police officers</u> regarding this chapter, section 6315(a)(3)
- 19 (relating to taking child into protective custody) and other
- 20 applicable provisions of Chapter 63 (relating to child
- 21 protective services) that relate to newborn protection. The
- 22 department shall promulgate such regulations as may be necessary
- 23 to implement this chapter, section 6315(a)(3) and other
- 24 applicable provisions of Chapter 63 that relate to newborn
- 25 protection. The department shall also provide health care
- 26 providers [and], hospitals, the Pennsylvania State Police and
- 27 <u>municipal police departments</u> with an informational pamphlet
- 28 regarding this chapter, section 6315(a)(3) and other applicable
- 29 provisions of Chapter 63 that relate to newborn protection which
- 30 may be distributed to the public. In addition, the department

- 1 shall comply with the provisions regarding infant abandonment in
- 2 sections 6365 (relating to services for prevention,
- 3 investigation and treatment of child abuse) and 6383 (relating
- 4 to education and training). A report shall be made annually to
- 5 the General Assembly on the number and disposition of newborns
- 6 accepted in accordance with this chapter, section 6315(a)(3) and
- 7 other applicable provisions of Chapter 63 that relate to newborn
- 8 protection.
- 9 Section 9. This act shall take effect in 60 days.
