AN ACT

Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying and enumerating certain subjects of taxation and imposing 3 taxes thereon; providing procedures for the payment, collection, administration and enforcement thereof; providing 5 for tax credits in certain cases; conferring powers and imposing duties upon the Department of Revenue, certain employers, fiduciaries, individuals, persons, corporations 8 and other entities; prescribing crimes, offenses and 9 penalties," in sales and use tax, further providing for 10 definitions. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Section 201(k)(8) and (o)(4)(B) of the act of 15 March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 16 1971, amended April 23, 1998 (P.L.239, No.45), are amended to 17 read: 18 SECTION 1. SECTION 201(K)(8), (0)(4)(B) AND (PP) OF THE ACT <--19 OF MARCH 4, 1971 (P.L.6, NO.2), KNOWN AS THE TAX REFORM CODE OF 1971, AMENDED OR ADDED APRIL 23, 1998 (P.L.239, NO.45), ARE 20 21 AMENDED TO READ:

- 1 Section 201. Definitions. -- The following words, terms and
- 2 phrases when used in this Article II shall have the meaning

- 13 The term "sale at retail" shall not include (i) any such
- 14 transfer of tangible personal property or rendition of services
- 15 for the purpose of resale, or (ii) such rendition of services or
- 16 the transfer of tangible personal property including, but not
- 17 limited to, machinery and equipment and parts therefor and
- 18 supplies to be used or consumed by the purchaser directly in the
- 19 operations of--
- 20 (A) The manufacture of tangible personal property.
- 21 (B) Farming, dairying, agriculture, timbering, horticulture
- 22 or floriculture when engaged in as a business enterprise. The
- 23 term "farming" shall include the propagation and raising of
- 24 ranch raised fur-bearing animals and the propagation of game
- 25 birds for commercial purposes by holders of propagation permits
- 26 issued under 34 Pa.C.S. (relating to game) and the propagation
- 27 and raising of horses to be used exclusively for commercial
- 28 racing activities. THE TERM "TIMBERING" SHALL INCLUDE:

- 12 (C) The producing, delivering or rendering of a public
- 13 utility service, or in constructing, reconstructing, remodeling,
- 14 repairing or maintaining the facilities which are directly used
- 15 in producing, delivering or rendering such service.
- 16 (D) Processing as defined in clause (d) of this section.
- The exclusions provided in paragraphs (A), (B), (C) and (D)
- 18 shall not apply to any vehicle required to be registered under
- 19 The Vehicle Code, except those vehicles used directly by a
- 20 public utility engaged in business as a common carrier; to
- 21 maintenance facilities; or to materials, supplies or equipment
- 22 to be used or consumed in the construction, reconstruction,
- 23 remodeling, repair or maintenance of real estate other than
- 24 directly used machinery, equipment, parts or foundations
- 25 therefor that may be affixed to such real estate.
- The exclusions provided in paragraphs (A), (B), (C) and (D)
- 27 shall not apply to tangible personal property or services to be
- 28 used or consumed in managerial sales or other nonoperational
- 29 activities, nor to the purchase or use of tangible personal
- 30 property or services by any person other than the person

- 3 The exclusion provided in paragraph (C) shall not apply to
- 4 (i) construction materials, supplies or equipment used to
- 5 construct, reconstruct, remodel, repair or maintain facilities
- 6 not used directly by the purchaser in the production, delivering
- 7 or rendition of public utility service, (ii) construction
- 8 materials, supplies or equipment used to construct, reconstruct,
- 9 remodel, repair or maintain a building, road or similar
- 10 structure, or (iii) tools and equipment used but not installed
- 11 in the maintenance of facilities used directly in the
- 12 production, delivering or rendition of a public utility service.
- The exclusions provided in paragraphs (A), (B), (C) and (D)
- 14 shall not apply to the services enumerated in clauses (k) (11)
- 15 through (18) and (w) through (kk), except that the exclusion
- 16 provided in this subclause for farming, dairying and agriculture
- 17 shall apply to the service enumerated in clause (z).

- 21 (4) The obtaining by a purchaser of the service of
- 22 repairing, altering, mending, pressing, fitting, dyeing,
- 23 laundering, drycleaning or cleaning tangible personal property
- 24 other than wearing apparel or shoes or applying or installing
- 25 tangible personal property as a repair or replacement part of
- 26 other tangible personal property other than wearing apparel or
- 27 shoes, whether or not the services are performed directly or by
- 28 any means other than by means of coin-operated self-service
- 29 laundry equipment for wearing apparel or household goods, and
- 30 whether or not any tangible personal property is transferred to

- 1 the purchaser in conjunction therewith, except such services as
- 2 are obtained in the construction, reconstruction, remodeling,
- 3 repair or maintenance of real estate: Provided, however, That
- 4 this subclause shall not be deemed to impose tax upon such
- 5 services in the preparation for sale of new items which are
- 6 excluded from the tax under clause (26) of section 204, or upon
- 7 diaper service: And provided further, That the term "use" shall

- 11 including but not limited to machinery and equipment and parts
- 12 therefor, and supplies or the obtaining of the services
- 13 described in subclauses (2), (3) and (4) of this clause directly
- 14 in the operations of--
- 15 (i) The manufacture of tangible personal property.
- 16 (ii) Farming, dairying, agriculture, timbering, horticulture
- 17 or floriculture when engaged in as a business enterprise. The
- 18 term "farming" shall include the propagation and raising of
- 19 ranch-raised furbearing animals and the propagation of game
- 20 birds for commercial purposes by holders of propagation permits

- 7 (iii) The producing, delivering or rendering of a public
- 8 utility service, or in constructing, reconstructing, remodeling,
- 9 repairing or maintaining the facilities which are directly used
- 10 in producing, delivering or rendering such service.
- 11 (iv) Processing as defined in subclause (d) of this section.
- 12 The exclusions provided in subparagraphs (i), (ii), (iii) and
- 13 (iv) shall not apply to any vehicle required to be registered
- 14 under The Vehicle Code except those vehicles directly used by a
- 15 public utility engaged in the business as a common carrier; to
- 16 maintenance facilities; or to materials, supplies or equipment
- 17 to be used or consumed in the construction, reconstruction,
- 18 remodeling, repair or maintenance of real estate other than
- 19 directly used machinery, equipment, parts or foundations
- 20 therefor that may be affixed to such real estate. The exclusions
- 21 provided in subparagraphs (i), (ii), (iii) and (iv) shall not
- 22 apply to tangible personal property or services to be used or
- 23 consumed in managerial sales or other nonoperational activities,
- 24 nor to the purchase or use of tangible personal property or
- 25 services by any person other than the person directly using the
- 26 same in the operations described in subparagraphs (i), (ii),
- 27 (iii) and (iv).
- The exclusion provided in subparagraph (iii) shall not apply
- 29 to (A) construction materials, supplies or equipment used to
- 30 construct, reconstruct, remodel, repair or maintain facilities

- 1 not used directly by the purchaser in the production, delivering
- 2 or rendition of public utility service or (B) tools and
- 3 equipment used but not installed in the maintenance of
- 4 facilities used directly in the production, delivering or
- 5 rendition of a public utility service.
- 6 The exclusion provided in subparagraphs (i), (ii), (iii) and
- 7 (iv) shall not apply to the services enumerated in clauses (o)
- 8 (9) through (16) and (w) through (kk), except that the exclusion
- 9 provided in subparagraph (ii) for farming, dairying and
- 10 agriculture shall apply to the service enumerated in clause (z).

- 12 (PP) "BUILDING MACHINERY AND EQUIPMENT." GENERATION <--
- 13 EQUIPMENT, STORAGE EQUIPMENT, CONDITIONING EQUIPMENT,
- 14 DISTRIBUTION EQUIPMENT AND TERMINATION EQUIPMENT, WHICH SHALL BE
- 15 LIMITED TO THE FOLLOWING:
- 16 (1) AIR CONDITIONING LIMITED TO HEATING, COOLING,
- 17 PURIFICATION, HUMIDIFICATION, DEHUMIDIFICATION AND VENTILATION;
- 18 (2) ELECTRICAL;
- 19 (3) PLUMBING;
- 20 (4) COMMUNICATIONS LIMITED TO VOICE, VIDEO, DATA, SOUND,
- 21 MASTER CLOCK AND NOISE ABATEMENT;
- 22 (5) ALARMS LIMITED TO FIRE, SECURITY AND DETECTION;
- 23 (6) CONTROL SYSTEM LIMITED TO ENERGY MANAGEMENT, TRAFFIC AND
- 24 PARKING LOT AND BUILDING ACCESS;
- 25 (7) MEDICAL SYSTEM LIMITED TO DIAGNOSIS AND TREATMENT
- 26 EQUIPMENT, MEDICAL GAS, NURSE CALL AND DOCTOR PAGING;
- 27 (8) LABORATORY SYSTEM;
- 28 (9) CATHODIC PROTECTION SYSTEM; OR
- 29 (10) FURNITURE, CABINETRY AND KITCHEN EQUIPMENT.
- 30 THE TERM SHALL INCLUDE BOILERS, CHILLERS, AIR CLEANERS,

- 1 HUMIDIFIERS, FANS, SWITCHGEAR, PUMPS, TELEPHONES, SPEAKERS,
- 2 HORNS, MOTION DETECTORS, DAMPERS, ACTUATORS, GRILLS, REGISTERS,
- 3 TRAFFIC SIGNALS, TRAFFIC SIGNAL FOUNDATIONS, POLES AND MAST
- 4 ARMS, SENSORS, CARD ACCESS DEVICES, GUARDRAILS, MEDIAL DEVICES,
- 5 FLOOR TROUGHS AND GRATES AND LAUNDRY EQUIPMENT, TOGETHER WITH
- 6 INTEGRAL COVERINGS AND ENCLOSURES, WHETHER OR NOT THE ITEM
- 7 CONSTITUTES A FIXTURE OR IS OTHERWISE AFFIXED TO THE REAL
- 8 ESTATE, WHETHER OR NOT DAMAGE WOULD BE DONE TO THE ITEM OR ITS
- 9 SURROUNDINGS UPON REMOVAL OR WHETHER OR NOT THE ITEM IS
- 10 PHYSICALLY LOCATED WITHIN A REAL ESTATE STRUCTURE. THE TERM
- 11 "BUILDING MACHINERY AND EQUIPMENT" SHALL NOT INCLUDE GUARDRAIL
- 12 POSTS, PIPES, FITTINGS, PIPE SUPPORTS AND HANGERS, VALVES,
- 13 UNDERGROUND TANKS, WIRE, CONDUIT, RECEPTACLE AND JUNCTION BOXES,
- 14 INSULATION, DUCTWORK AND COVERINGS THEREOF.

- 16 Section 2. This act shall take effect in 60 days.
