## AN ACT

- 1 Providing for middle income student debt reduction; and imposing powers and duties on the Pennsylvania Higher Education
- 3 Assistance Agency.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 CHAPTER 1
- 7 GENERAL PROVISIONS
- 8 Section 101. Short title.
- 9 This act shall be known and may be cited as the Middle Income
- 10 Student Debt Reduction Act.
- 11 Section 102. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Agency." The Pennsylvania Higher Education Assistance
- 16 Agency.

- 1 "Approved institution of higher education." Any institution
- 2 of higher learning approved by the agency.
- 3 "Family financial data." Income information submitted to the
- 4 agency by a middle income student applicant, an applicant's
- 5 parents and stepparent and the applicant's spouse, as required
- 6 under 22 Pa. Code § 121.44 (relating to required family
- 7 financial data).
- 8 "Financial need." The need of a full-time student or half-
- 9 time student satisfying the middle income requirement of this
- 10 act.
- "Full-time student." A student carrying a full-time academic
- 12 workload the equivalent of any of the following:
- 13 (1) Twelve semester credits.
- 14 (2) Four hundred and fifty clock hours of instruction
- 15 per academic term.
- 16 (3) If the schedule of a program of study offered on a
- 17 clock-hour basis does not permit the equivalent of 450 clock
- hours of instruction per academic term, 24 clock hours of
- instruction per week.
- 20 "Grant program." A grant program administered by the agency
- 21 under this act.
- 22 "Half-time student." A student with at least half the
- 23 academic workload of a full-time student.
- "Middle income requirement." As follows:
- 25 (1) A middle income student whose family financial data
- indicates an annual family income of at least \$80,000 but not
- 27 more than \$110,000 and has demonstrated financial need as
- determined by the agency.
- 29 (2) Beginning July 1, 2014, the agency shall annually
- 30 adjust the middle income requirement amounts under paragraph

- 1 (1) to reflect any upward changes in the Consumer Price Index
- for All Urban Consumers for the Pennsylvania, New Jersey,
- 3 Delaware and Maryland area in the preceding 12 months.
- 4 "Middle income student." A full-time or half-time student
- 5 satisfying the middle income requirement.
- 6 "Parent." A middle income student's mother, father or legal
- 7 quardian.
- 8 Section 103. Legislative purpose.
- 9 The General Assembly finds as follows:
- 10 (1) Since 1965, the Pennsylvania Higher Education
- 11 Assistance Agency has provided over 5,000,000 financial aid
- 12 awards to needy Pennsylvania students attending and pursuing
- a postsecondary education through its administration of the
- 14 PHEAA grant program.
- 15 (2) The income limits for the agency's student financial
- assistance program, however, are set at a range that
- 17 precludes many middle income students from the opportunity of
- 18 receiving a State grant to pursue their postsecondary
- 19 endeavors.
- 20 (3) With the cost of higher education increasing,
- 21 financial aid should be expanded to reduce debt on middle
- income students.
- 23 (4) It is the intent of this General Assembly and the
- 24 purpose of this act to establish a targeted State grant
- 25 program to assist the Commonwealth's students from middle-
- 26 income families and give them the opportunity to continue
- their program of self-improvement in an approved institution
- of higher education of their choice.
- 29 (5) The grant program created shall augment and not
- 30 replace other State-supported financial aid.

1 CHAPTER 2

2 GRANT PROGRAM

- 3 Section 201. Administration.
- 4 This act shall be administered by the agency.
- 5 Section 202. Agency.
- 6 (a) Powers and duties. -- The agency shall have the following
- 7 powers and duties:
- 8 (1) To prepare and supervise the issuance of public
- 9 information concerning the provisions of the grant program.
- 10 (2) To prescribe the form and regulate the submission of
- 11 applications for grants.
- 12 (3) To determine if an applicant meets middle income
- 13 requirements and is eligible for a grant under this act.
- 14 (4) To select qualified recipients.
- 15 (5) To award the appropriate grants.
- 16 (6) To determine eligibility for, and annual renewal of,
- 17 grants.
- 18 (b) Authorization. -- The agency is authorized to make
- 19 necessary rules, consistent with this act, for the efficient
- 20 exercise of the functions under subsection (a).
- 21 Section 203. Additional responsibilities.
- The agency shall assume the same duties, responsibilities and
- 23 relationships for this act as for the following:
- 24 (1) The act of August 7, 1963 (P.L.549, No.290),
- 25 referred to as the Pennsylvania Higher Education Assistance
- 26 Agency Act.
- 27 (2) The act of January 25, 1966 (1965 P.L.1546, No.541),
- referred to as the Higher Education Scholarship Law.
- 29 CHAPTER 3
- 30 ELIGIBILITY

- 1 Section 301. Eligibility.
- 2 A student shall be eligible for consideration for a grant if
- 3 the student meets all of the following criteria:
- 4 (1) Middle income requirements established under this
- 5 act.
- 6 (2) Citizen requirements of 22 Pa. Code § 121.2
- 7 (relating to citizenship).
- 8 (3) Domicile requirements of 22 Pa. Code § 121.57
- 9 (relating to higher education grant domicile).
- 10 (4) Graduation requirements of 22 Pa. Code § 121.21
- 11 (relating to requirement for higher education grant
- 12 applicants).
- 13 (5) Character and academic promise, as established by
- 14 the agency.
- 15 Section 302. Choice.
- 16 The grant recipient shall be free to attend any approved
- 17 institution of higher education of the recipient's choice and
- 18 apply the grant toward the agency's allowable education costs of
- 19 that institution. The institution shall not be required to
- 20 accept the grant recipient for enrollment, but may require
- 21 compliance with its admission requirements, standards and
- 22 policies.
- 23 Section 303. Special provisions.
- 24 (a) Nondiscrimination. -- Grant awards must be made without
- 25 regard to the applicant's race, creed, color, sex, national
- 26 origin or ancestry.
- 27 (b) Eligibility.--Students who are declared eligible for
- 28 first year undergraduate awards but do not receive a grant
- 29 because they are not able to demonstrate that they meet the
- 30 middle income requirements may be awarded a grant during their

- 1 undergraduate study at any time that they are able to
- 2 demonstrate that they meet the eligibility requirements under
- 3 this act. Nothing under this act shall preclude a student who
- 4 fails to meet the middle income requirement from applying for or
- 5 receiving a grant, loan or award from the agency.
- 6 (c) Limit.--Undergraduate awards granted during the first
- 7 year shall be limited to students currently enrolled or accepted
- 8 for enrollment at an approved institution of higher education.
- 9 Awards shall be based on the level of appropriation provided
- 10 annually by the Commonwealth's enacted budget for this program
- 11 and as determined by the agency. Awards shall be renewable under
- 12 Chapter 6 and agency policy.
- 13 (d) Age.--Any middle income student qualifying for a grant
- 14 may not be disqualified because the student is under 18 years of
- 15 age. For the purpose of applying for and receiving grants, an
- 16 individual under 18 years of age shall be deemed to have full
- 17 legal capacity to act and shall have all the rights, powers,
- 18 privileges and obligations of an individual of full age.
- 19 (e) Other grants.--If a student fails to meet the middle
- 20 income requirements under this act, but meets the requirements
- 21 of another grant, loan or award issued by the agency, the agency
- 22 shall notify the student applicant of the other grant, loan or
- 23 award that the student may be eligible for and direct the
- 24 student's application to the appropriate administrative office
- 25 within the agency for consideration, except that a student
- 26 eligible for an award under this act may not simultaneously be
- 27 eligible for a Pennsylvania State Grant award.
- 28 CHAPTER 4
- 29 SELECTION
- 30 Section 401. Grouping of applicants.

- 1 The agency shall select from among current applicants those
- 2 students currently enrolled or accepted for enrollment in an
- 3 approved institution of higher education who, in the agency's
- 4 sole discretion, are successfully pursuing a course of study or
- 5 who have been accepted as first year undergraduate students and
- 6 who need financial assistance to complete their educational
- 7 programs.
- 8 Section 402. Grant awards.
- 9 (a) Amount. -- The amount of the grant to a middle income
- 10 student shall be determined on the basis of the financial need
- 11 of the applicant, the funds available for grants and the number
- 12 of eligible applicants for grants.
- 13 (b) Need analysis procedures. -- Grants awarded to eligible
- 14 middle income student applicants shall be determined according
- 15 to the need analysis procedures established annually by the
- 16 agency and published in the State Higher Education Grant Program
- 17 Manual as required under 22 Pa. Code § 121.47 (relating to State
- 18 Higher Education Grant Program Manual). Financial need shall be
- 19 computed according to policies established by the agency.
- 20 CHAPTER 5
- 21 FUNDS
- 22 Section 501. Appropriation and financial need.
- 23 (a) Appropriation. -- For fiscal year 2013-2014, the sum of
- 24 \$36,000,000 is appropriated to the agency for middle income
- 25 higher education grants. Funding for the middle income higher
- 26 education grant program shall be provided from an annual
- 27 appropriation by the General Assembly.
- 28 (b) Financial need.--All middle income student grant awards
- 29 will be based on the applicant's financial need. The minimum
- 30 grant award for middle income students shall be determined

- 1 annually by the board of directors of the agency. The maximum
- 2 grant for middle income students shall be established annually
- 3 by the board of directors of the agency at a level so as to keep
- 4 expenditures within the funds available through reenactment of
- 5 appropriations relating to the forward funding of the PHEAA
- 6 grant program as provided for under the act of March 28, 1974
- 7 (P.L.228, No.50), referred to as the Higher Education Assistance
- 8 Continuation Law, and from funds appropriated or made available
- 9 from Federal, State or other sources for grants during a fiscal
- 10 year.
- 11 (c) Limitation. -- The total State financial assistance may
- 12 not exceed the financial need of the applicant or the annual
- 13 limits established under the authority of this act and the act
- 14 of August 7, 1963 (P.L.549, No.290), referred to as the
- 15 Pennsylvania Higher Education Assistance Agency Act. If awards
- 16 exceed available resources, applicants shall be funded as the
- 17 agency shall determine.
- 18 CHAPTER 6
- 19 GRANT RENEWAL
- 20 Section 601. Use of grants.
- 21 (a) Renewal.--
- 22 (1) Each grant shall be renewable until the program of
- study is completed, but may not exceed an additional three
- full-time academic years or its equivalent beyond the first
- year of the award or an additional four academic years for
- 26 students enrolled in five-year undergraduate programs of
- study approved by the agency. Additional years may be
- 28 consecutive or nonconsecutive years.
- 29 (2) Qualifications for renewal shall include maintaining
- 30 satisfactory academic standing, making normal progress toward

- 1 completion of the course of study and continued eligibility
- 2 as determined by the agency, including legal Pennsylvania
- 3 residency.
- 4 (b) Transfer. -- If a grant recipient transfers from one
- 5 eligible institution to another, the recipient's grant shall be
- 6 transferable only with the approval of the agency.
- 7 (c) Additional grants. -- The agency shall have the right to
- 8 use the unused grant funds for additional grants in any fiscal
- 9 year and in any category.
- 10 (d) Payments. -- Payments of grants shall be made by the
- 11 agency in accordance with this act and the rules and regulations
- 12 established by the agency. If the recipient terminates
- 13 enrollment during the academic year, the unused portion of the
- 14 grant shall be returned to the agency by the institution
- 15 according to the institution's own policy for issuing refunds.
- 16 CHAPTER 7
- 17 DENIAL
- 18 Section 701. Procedure.
- 19 (a) Grounds. -- The agency may deny financial assistance to a
- 20 middle income student that meets any of the following:
- 21 (1) Is convicted of any of the offenses listed under 22
- 22 Pa. Code § 121.6 (relating to denial of eligibility for
- 23 financial assistance).
- 24 (2) Has been expelled, dismissed or denied enrollment by
- an approved institution of higher education.
- 26 (3) Has defaulted on a loan under 22 Pa. Code § 121.4
- 27 (relating to denial of eligibility to loan defaulters).
- 28 (b) Appeal.--A middle income student who is denied financial
- 29 assistance may follow appeal procedures under 22 Pa. Code §
- 30 121.7 (relating to notice of denial and preliminary review

- 1 procedures) and 22 Pa. Code § 121.8 (relating to applicant and
- 2 recipient appeals and hearings).
- 3 (c) Information. -- Each approved institution of higher
- 4 education shall, within ten business days, furnish to the
- 5 agency, the name and address of a student who is a resident of
- 6 this Commonwealth and who is expelled, dismissed or denied
- 7 enrollment or of whom the approved institution of higher
- 8 education has knowledge that the student has been convicted of
- 9 an offense under subsection (a) (1).
- 10 (d) Refund. -- Whenever a recipient fails to complete a term,
- 11 the agency shall initiate refund procedures under 22 Pa. Code §
- 12 121.51 (relating to refund of State higher education grants).
- 13 (e) Status. -- Any institution of higher learning which
- 14 refuses to execute an agreement with the agency to comply with
- 15 subsection (c) shall be denied the status of an approved
- 16 institution of higher education under this act.
- 17 CHAPTER 9
- 18 MISCELLANEOUS PROVISIONS
- 19 Section 901. Effective date.
- This act shall take effect July 31, 2013, or immediately,
- 21 whichever is later.
