## AN ACT

Amending the act of April 14, 1972 (P.L.233, No.64), entitled "An act relating to the manufacture, sale and possession of controlled substances, other drugs, devices and cosmetics; 3 conferring powers on the courts and the secretary and Department of Health, and a newly created Pennsylvania Drug, Device and Cosmetic Board; establishing schedules of controlled substances; providing penalties; requiring 7 registration of persons engaged in the drug trade and for the 8 revocation or suspension of certain licenses and 9 registrations; and repealing an act," further providing for 10 schedules of controlled substances. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Section 4(1)(vii) of the act of April 14, 1972 (P.L.233, No.64), known as The Controlled Substance, Drug, Device and Cosmetic Act, amended June 20, 2011 (P.L.86, No.7), 16 17 is amended and the paragraph is amended by adding a subparagraph 18 to read: 19 Section 4. Schedules of Controlled Substances. The 20 following schedules include the controlled substances listed or
