Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in pupils and attendance, further providing for cost of tuition and maintenance of certain 5 6 exceptional children in approved institutions. 7 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 1376 of the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, is 11 12 amended by adding a subsection to read: 13 Section 1376. Cost of Tuition and Maintenance of Certain Exceptional Children in Approved Institutions. -- * * * 14 (c.9) (1) Beginning in fiscal year 2014-2015, in any fiscal 15 16 year when there is no increase in the State allocation to approved private schools under subsection (a.2), an amount equal 17 to the funds remitted to the Commonwealth by the approved 18

private schools pursuant to subsection (c.2)(5)(ii) from the

- 1 previous fiscal year is appropriated to the Department of
- 2 Education for the purpose of making payments to the approved
- 3 private schools for pupils who are enrolled with the approval of
- 4 the Department of Education.
- 5 (2) The funds available for payment pursuant to paragraph
- 6 (1) shall be distributed as follows:
- 7 (i) Divide the amount of funding paid to the approved
- 8 private school during the previous year under subsection (a.2)
- 9 by the total allocation of funding paid to approved private
- 10 schools under subsection (a.2) during the previous year.
- 11 (ii) Multiply the quotient from subparagraph (i) by the
- 12 <u>amount of funding available for payment under paragraph (1).</u>
- 13 (3) Funds distributed under this subsection shall be paid in
- 14 <u>twelve (12) equal monthly payments.</u>

- 16 Section 2. This act shall take effect July 1, 2014, or
- 17 immediately, whichever occurs first.
