AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, further providing for the offense of luring a child into a motor vehicle or structure.
- 3 Iuling a child into a motor vehicle of Structure.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 2910 of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 2910. Luring a child into a motor vehicle or structure.
- 9 (a) Offense.--Unless the circumstances reasonably indicate
- 10 that the child is in need of assistance, a person who lures or
- 11 attempts to lure a child into a motor vehicle or structure
- 12 without the consent, express or implied, of the child's parent
- 13 or guardian commits [a misdemeanor of the first degree] an
- 14 offense.
- 15 (a.1) Grading. -- The following shall apply:
- 16 (1) Except as provided under paragraph (2), an offense

- 1 <u>under subsection (a) is a misdemeanor of the first degree.</u>
- 2 (2) If an offense under subsection (a) involves a child
- 3 less than 13 years of age, the offense is a felony of the
- 4 <u>second degree.</u>
- 5 (a.2) Mistake as to age. -- If an offense under subsection (a)
- 6 <u>involves a child less than 13 years of age, it shall be no</u>
- 7 defense that the defendant did not know the age of the child or
- 8 reasonably believed the child to be 13 years of age or older.
- 9 (b) Affirmative defense. -- It shall be an affirmative defense
- 10 to a prosecution under this section that the person lured or
- 11 attempted to lure the child into the structure for a lawful
- 12 purpose.
- 13 (c) Definitions.--As used in this section, the following
- 14 words and phrases shall have the meanings given to them in this
- 15 subsection:
- 16 "Child." A person under 18 years of age.
- 17 "Motor vehicle." Every self-propelled device in, upon or by
- 18 which any person or property is or may be transported or drawn
- 19 on a public highway.
- 20 "Structure." A house, apartment building, shop, warehouse,
- 21 barn, building, vessel, railroad car, cargo container, house
- 22 car, trailer, trailer coach, camper, mine, floating home or
- 23 other enclosed structure capable of holding a child, which is
- 24 not open to the general public.
- 25 Section 2. This act shall take effect in 60 days.
