## AN ACT

1 2 3 4 5	Approving the release of Project 70 restrictions on certain land owned by the Borough of Downingtown, Chester County, in return for the development of public park improvements within Kardon Park within the Borough of Downingtown and East Caln Township, Chester County; and making a related repeal.
6	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. Release of restrictions in Chester County.
9	(a) Authorization Pursuant to the requirements of section
10	20(b) of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8),
11	known as the Project 70 Land Acquisition and Borrowing Act, the
12	General Assembly approves the release of Project 70 restrictions
13	from the land owned by the Borough of Downingtown, Chester
14	County, which is more particularly described in subsection (c)
15	in accordance with the following conditions:
16	(1) The following apply to consideration:
17	(i) Project 70 restrictions removed from the land
18	described in subsection (c) shall be for \$285,000, which
19	is the fair market value of the restrictions as
20	established by a self-contained appraisal report prepared

- by a State-certified general appraiser certified under the act of July 10, 1990 (P.L.404, No.98), known as the Real Estate Appraisers Certification Act.
  - (ii) Any land within the area described in subsection (c) sold by the Borough of Downingtown, without Project 70 restrictions, shall be for an amount equal to or greater than the fair market value of the land as established by a self-contained appraisal report prepared by a State-certified general appraiser certified under the Real Estate Appraisers Certification Act.
  - (2) The proceeds of the sale of the land and the release of the Project 70 restrictions shall be deposited into an interest-bearing account established by the Borough of Downingtown and designated solely for the purposes of the conditions under this subsection.
  - (3) The money in the interest-bearing account shall be used by the Borough of Downingtown for the sole purpose of improvements to Kardon Park in accordance with a development plan, including:
    - (i) Construction plans and specifications prepared by a licensed engineer or landscape architect and preapproved in writing by the department.
- 23 (ii) The following improvements for use by the public:
- 25 (A) Trails.
- 26 (B) Pedestrian bridges.
- (C) Parking.
- 28 (D) Docks and boating slips.
- 29 (E) Enhancements to the water quality and 30 quantity of the ponds and millrace. This clause

5	(F) Wetlands plantings.

16	(4) The Borough of Downingtown shall certify to the
17	department that an area of land matching the metes and bounds
18	description in subsection (d) has been deed restricted for
19	public park use, which (deed restriction) has been recorded
20	by the Borough of Downingtown in the form and substance
21	acceptable to the department. The department and the Borough
22	of Downingtown may mutually agree on adjustments to the metes
23	and bounds of the public park land as long as the public park
24	land is not less than 20.0 acres in size.
25	(b) Use of money securing the public park improvementsIn
26	accordance with the requirements set forth in subsection (a):
27	(1) The money, including interest, shall be used solely
28	to ensure the development of public park improvements within
29	Kardon Park constructed or caused to be constructed by the

Borough of Downingtown in accordance with the plan approved

- 1 by the department. The money shall be released for the
- 2 development of the Kardon Park following approval of the
- development plan as set forth in subsection (a) (3).
- 4 (2) Any money, including interest, remaining five years
- 5 after the date the money is deposited, unless extended by the
- 6 department for a period not to exceed two years, shall
- 7 immediately be paid to the department for deposit in the
- 8 department's General Restricted Revenue Fund for the purpose
- 9 of funding conservation and recreation grants. Failure to
- 10 make the payment shall result in the amount of money,
- including interest, constituting a debt by the Borough of
- Downingtown to the Commonwealth.
- 13 (c) Land subject to the release from Project 70
- 14 restrictions. -- The land which is subject to the release from
- 15 Project 70 restrictions in accordance with the provisions under
- 16 subsection (a) is as follows:
- 17 All that certain tract of land situate in East Caln Township,

- 70 Park Plan" prepared by Commonwealth Engineers, Inc.,

- 9 All that certain tract of land situate in Downingtown Borough
- 10 and East Caln Township, Chester County, Pennsylvania, as
- 11 shown on a plan entitled "Park Area Legal Description Plan"
- 12 prepared by Commonwealth Engineers, Inc., Downingtown,
- Pennsylvania, dated September 7, 2012, and being more fully
- 14 described as follows:
- Beginning at an existing railroad spike (set) located in the
- center of Norwood Road, said point being the northwestern
- corner of parcel 4001 0023010e in East Caln Township, Chester
- 18 County, Pennsylvania, and the true point of beginning;
- 19 Thencefrom the beginning of left curve from which the radius
- 20 point bears north 28°51'05" west, northeasterly a distance of
- 21 97.93 feet along the curve concave to the northwest, having a
- radius of 345.61 feet and a central angle of 16°14'03";
- Thence south 50°28'53" east, a distance of 54.93 feet to the
- 24 beginning of a curve tangent to said line;
- 25 Thence southeasterly a distance of 21.74 feet along the curve
- 26 concave to the southwest, having a radius of 117.50 feet and

- 1 Thence south 75°47'08" west, a distance of 39.06 feet;

- 4 Containing .990 acres.
- 5 Total restricted park property contains 20.097 acres, more or
- 6 less.
- 7 (e) Definition.--As used in this section, the term
- 8 "department" means the Department of Conservation and Natural
- 9 Resources of the Commonwealth.
- 10 Section 2. Repeal.
- 11 (a) Declaration of policy. -- The General Assembly declares
- 12 that the repeal under subsection (b) is necessary to effectuate
- 13 section 1.
- 14 (b) Provision. -- Section 6 of the act of October 24, 2012
- 15 (P.L.1293, No.162), entitled "An act authorizing the Department
- 16 of Conservation and Natural Resources to release, upon the
- 17 satisfaction of certain conditions, Project 70 restrictions on
- 18 certain land owned by the West Rockhill Sellersville Joint
- 19 Recreation Authority, Bucks County; authorizing the conveyance
- 20 of an easement and the release of Project 70 restrictions
- 21 imposed on a portion of land owned by the Pennsylvania Fish and
- 22 Boat Commission in Gamble Township, Lycoming County, in return
- 23 for the imposition of Project 70 restrictions on certain land
- 24 being conveyed to the commission in Gamble Township, Lycoming
- 25 County, and other terms and conditions; authorizing the sale and
- 26 transfer of title for Project 70 lands owned by Erie County to
- 27 Springfield Township, Erie County; authorizing Westmoreland
- 28 County to convey and transfer a fee interest in certain Project
- 29 70 land in Unity Township free of Project 70 restrictions in
- 30 return for the imposition of Project 70 restrictions on other

- 1 land in Unity Township to be acquired by Westmoreland County;
- 2 authorizing the Department of General Services, with the
- 3 approval of the Department of Military and Veterans Affairs and
- 4 the Governor, to grant and convey to QRS Realty Corp. certain
- 5 lands and building situate in the City of Erie, Erie County; and
- 6 approving the release of Project 70 restrictions on certain land
- 7 owned by the Borough of Downingtown, Chester County, in return
- 8 for the development of public park improvements within Kardon
- 9 Park within the Borough of Downingtown and East Caln Township,
- 10 Chester County," is repealed.
- 11 Section 3. This act shall take effect immediately.
