AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in duties and powers of boards of 5 school directors, providing for notice prior to approval of 7 collective bargaining agreement. The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 10 11 as the Public School Code of 1949, is amended by adding a 12 section to read: 13 Section 1153-A. Notice Prior to Approval of Collective Bargaining Agreement. -- (a) A board of school directors of any 14 15 school district shall provide notice prior to voting upon any 16 proposed collective bargaining agreement OR UPON ANY PROPOSED <--

EMPLOYMENT CONTRACT FOR A PROFESSIONAL EDUCATOR WHO IS NOT A

MEMBER OF AN EMPLOYE ORGANIZATION. The notice required under

- 1 this section shall:
- 2 (1) Be posted on the school district's publicly accessible
- 3 Internet website beginning at least forty-eight (48) hours prior
- 4 to the public meeting of the board of school directors at which
- 5 the board of school directors votes upon the proposed collective
- 6 bargaining agreement OR EMPLOYMENT CONTRACT and continuing at <--
- 7 <u>least until thirty (30) days following the conclusion of such</u>
- 8 public meeting.
- 9 (2) Be published at least one (1) time in a newspaper of
- 10 general circulation in the school district at least forty-eight
- 11 (48) hours prior to the public meeting of the board of school
- 12 <u>directors at which the board of school directors votes upon the</u>
- 13 proposed collective bargaining agreement OR EMPLOYMENT CONTRACT. <--
- 14 <u>(3) Include the following:</u>
- (i) a statement of the terms of the proposed collective
- 16 <u>bargaining agreement OR EMPLOYMENT CONTRACT; and</u>
- 17 (ii) an estimate of the costs to the school district
- 18 <u>associated with the proposed collective bargaining agreement OR</u> <--

- 19 EMPLOYMENT CONTRACT.
- 20 (b) The notice requirements of this section shall not apply
- 21 to section 1125-A(k).
- 22 (c) The Department of Education shall promulgate regulations
- 23 pursuant to the act of June 25, 1982 (P.L.633, No.181), known as
- 24 the "Regulatory Review Act," to set forth the form of the notice
- 25 required under subsection (a).
- 26 Section 2. This act shall take effect in 60 days.
