Section 9799.12 of Title 42 of the Pennsylvania 8 Consolidated Statutes is amended by adding a definition to read: 10 § 9799.12. Definitions. 11 The following words and phrases when used in this subchapter 12 shall have the meanings given to them in this section unless the 13 context clearly indicates otherwise: 14 15 "Social networking website." An Internet website, the 16 primary purpose of which is social interaction with other users

- 5 (b) Information provided by sexual offender. -- An individual

- 12 <u>functionality of a social networking website shall state that</u>
- 13 the individual is a sexual offender within the individual's
- 14 username.
- 15 Section 4. This act shall take effect in 60 days.
