AN ACT

- 1 Providing for municipal regulation of the deposit, disposal or
- land application of biosolid material; and requiring a public
- 3 referendum under certain circumstances.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Biosolid
- 8 Material Municipal Regulation Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Affected municipality." A municipality in which biosolid
- 14 material is intended to be deposited, disposed of or applied to
- 15 land or that would be directly affected by the deposition,
- 16 disposal of or application to land of biosolid material in the
- 17 municipality.
- 18 "Biosolid material." Liquid or solid sludges and other

- 1 residues from a municipal sewage collection and treatment
- 2 system; and liquid or solid sludges and other residues from
- 3 septic and holding tank pumpings from commercial, institutional
- 4 or residential establishments. The term includes materials
- 5 derived from sewage sludge. The term does not include ash
- 6 generated during the firing of sewage sludge in a sewage sludge
- 7 incinerator, grit and screenings generated during preliminary
- 8 treatment of sewage sludge at a municipal sewage collection and
- 9 treatment system or grit, screenings and nonorganic objects from
- 10 septic and holding tank pumpings.
- 11 "Department." The Department of Environmental Protection of
- 12 the Commonwealth.
- "Deposit, disposal or land application site." The physical
- 14 location where biosolid material is intended to be deposited,
- 15 disposed or applied in an affected municipality.
- 16 "Permit." A document issued by the department that grants a
- 17 person, party, corporation or governmental entity the
- 18 authorization to deposit, dispose or apply biosolid material or
- 19 any composition containing biosolid material in a municipality.
- 20 "Permit application." A request or petition to the
- 21 department seeking authorization by a person, party, corporation
- 22 or governmental entity to deposit, dispose or apply biosolid
- 23 material or any composition containing biosolid material in a
- 24 municipality.
- 25 Section 3. Biosolid material ordinances.
- 26 (a) General rule. -- Subject to the provisions of subsections
- 27 (b) and (c), a municipality may adopt and enforce ordinances
- 28 regulating the deposit, testing, disposal or land application of
- 29 biosolid material.
- 30 (b) Relationship to other law.--A municipal ordinance

- 1 regulating the deposit, disposal or land application of biosolid
- 2 material must be at least as stringent as the requirements of
- 3 the act of July 7, 1980 (P.L.380, No.97), known as the Solid
- 4 Waste Management Act, and the regulations promulgated under that
- 5 act.
- 6 (c) Biosolid testing. -- A municipality may adopt an ordinance
- 7 or resolution authorizing the municipality to conduct tests of
- 8 land for the deposits of the biosolid material, for the biosolid
- 9 material itself, or both. The expense of the tests must be paid
- 10 by:
- 11 (1) the entity that applied the biosolid material;
- 12 (2) the owner of the land; or
- 13 (3) the transporter of the biosolid material.
- 14 Upon written complaint of any person, the department may enter
- 15 upon any land in this Commonwealth and conduct tests of the land
- 16 for the application of biosolid material without prior notice to
- 17 the owner of the land.
- 18 Section 4. Municipal veto.
- 19 In addition to the requirements of the act of July 7, 1980
- 20 (P.L.380, No.97), known as the Solid Waste Management Act, a
- 21 municipality may veto, provided that the provisions of section 5
- 22 are satisfied, a permit application approved by the department
- 23 for the deposit, disposal or land application of biosolid
- 24 material.
- 25 Section 5. Existing permits.
- Any permit issued by the department on or after January 1,
- 27 2014, that authorizes the deposit, disposal or land application
- 28 of biosolid material is hereby declared null and void.
- 29 Section 6. Effective date.
- This act shall take effect in 60 days.
