## AN ACT

Conveyance in Harrisburg and Susquehanna Township, <--28 Dauphin County. 29 (a) Authorization. The Department of General Services, with 30 the approval of the Governor, is hereby authorized on behalf of 31 the Commonwealth of Pennsylvania to grant and convey, at a price 32 to be determined through competitive bidding, the land described 33 in subsection (b) together with any buildings, structures or improvements thereon, situate partly in the City of Harrisburg 34 35 and partly in Susquehanna Township, Dauphin County, 36 Pennsylvania. 37 (b) Property description. Except as otherwise provided in 38 subsection (c), the property to be conveyed pursuant to this 39 section consists of the following described tract or tracts of 40 land, and all improvements located thereon, bounded and more 41 particularly described as follows: 42 ALL THAT CERTAIN tract or tracts of land, and all

- 3 (c) Survey required. -- The final legal description of the-
- 4 property to be sold shall be established by a survey prepared by
- 5 a Pennsylvania licensed land surveyor under a contract with the
- 6 Department of General Services. The property to be sold shall
- 7 exclude the following Commonwealth owned facilities, including
- 8 suitable grounds therefore and such easements and other
- 9 appurtenances as are necessary or desirable for the current and
- 10 future operation of such facilities, each of which is currently
- 11 located on a portion of the property:
- 12 (1) Pennsylvania State Police Headquarters.

- 29 Commonwealth operations as determined by the Department of
- 30 General Services.

- 1 The Department of General Services shall consult with each
- 2 entity having jurisdiction and control over the facilities-
- 3 enumerated in this subsection or any other portion of the
- 4 property before establishing final property boundaries to ensure-
- 5 that adequate property is retained for current and future
- 6 operations. The subdivision of this property shall be exempt
- 7 from the provisions of the act of July 31, 1968 (P.L.805,
- 8 No.247), known as the Pennsylvania Municipalities Planning Code,
- 9 and local subdivision and land development ordinances.
- 10 (d) Conditions. The conveyance shall be made under and
- 11 subject to all lawful and enforceable easements, servitudes and
- 12 rights of others, including but not confined to streets,
- 13 roadways and rights of any telephone, telegraph, water,
- 14 electric, gas or pipeline companies, as well as under and
- 15 subject to any lawful and enforceable estates or tenancies
- 16 vested in third persons appearing of record, for any portion of
- 17 the land or improvements erected thereon.
- 18 (e) Licensed facilities prohibited. Any conveyance
- 19 authorized under this section shall be made under and subject to
- 20 the condition, which shall be contained in the deed of
- 21 conveyance, that no portion of the property conveyed shall be
- 22 used as a licensed facility, as defined in 4 Pa.C.S. § 1103
- 23 (relating to definitions), or any other similar type of facility
- 24 authorized under State law. The condition shall be a covenant
- 25 running with the land and shall be binding upon the Grantee, its-
- 26 successors and assigns. Should the Grantee, its successors or
- 27 assigns, permit any portion of the property authorized to be-
- 28 conveyed in this act to be used in violation of this subsection,
- 29 the title shall immediately revert to and revest in the Grantor.
- 30 (f) Deed of conveyance. The deed of conveyance shall be by

- 1 Special Warranty Deed and shall be executed by the Secretary of
- 2 General Services in the name of the Commonwealth of
- 3 <del>Pennsylvania.</del>
- 4 (g) Costs and fees. Costs and fees incidental to this
- 5 conveyance shall be borne by the Grantee.
- 6 (h) Time period for conveyance. In the event that the
- 7 Department of General Services does not convey the property
- 8 within ten years of the effective date of this section, the
- 9 authority contained in this section shall become null and void.
- 10 (i) Deposit of proceeds. The proceeds from the sale shall
- 11 be deposited in the General Fund.
- 12 Section 2. Effective date.
- 13 This act shall take effect immediately.

- 1 (C) SURVEY REQUIREMENTS. -- THE FINAL LEGAL DESCRIPTION OF THE
- 2 PROPERTY TO BE SURVEYED SHALL BE ESTABLISHED BY A SURVEY
- 3 PREPARED BY A PENNSYLVANIA-LICENSED LAND SURVEYOR UNDER A
- 4 CONTRACT WITH THE DEPARTMENT OF GENERAL SERVICES. THE PROPERTY
- 5 TO BE SURVEYED SHALL EXCLUDE THE FOLLOWING COMMONWEALTH-OWNED
- 6 FACILITIES, INCLUDING SUITABLE GROUNDS THEREFORE AND SUCH
- 7 EASEMENTS AND OTHER APPURTENANCES AS ARE NECESSARY OR DESIRABLE
- 8 FOR THE CURRENT AND FUTURE OPERATION OF SUCH FACILITIES, EACH OF
- 9 WHICH IS CURRENTLY LOCATED ON A PORTION OF THE PROPERTY:

- 9 THAT INCLUDES ALL LAWFUL AND ENFORCEABLE EASEMENTS, SERVITUDES
- 10 AND RIGHTS OF OTHERS, INCLUDING BUT NOT CONFINED TO STREETS,
- 11 ROADWAYS, GREENSPACE AND RIGHTS OF ANY TELEPHONE, TELEGRAPH,
- 12 WATER, ELECTRIC, GAS OR PIPELINE COMPANIES, AS WELL AS UNDER AND
- 13 SUBJECT TO ANY LAWFUL AND ENFORCEABLE ESTATES OR TENANCIES
- 14 VESTED IN THIRD PERSONS APPEARING OF RECORD, FOR ANY PORTION OF
- 15 THE LAND OR IMPROVEMENTS ERECTED THEREON.
- 16 (E) REPORT.--UPON COMPLETION OF THE SURVEY, THE DEPARTMENT
- 17 OF GENERAL SERVICES SHALL PRESENT A PLAN FOR CONVEYANCE TO BOTH
- 18 HOUSES OF THE GENERAL ASSEMBLY THAT INCLUDES A RECOMMENDED
- 19 DIVISION OF THE PROPERTY AND THE FAIR MARKET VALUE OF EACH
- 20 PARCEL. FOLLOWING RECEIPT OF THE PLAN, THE GENERAL ASSEMBLY MAY <--
- 21 ENACT LEGISLATION TO AUTHORIZE THE TRANSFER OF THE LAND
- 22 DESCRIBED UNDER SUBSECTION (B).
- 23 (F) ZONING.--THE DEPARTMENT OF GENERAL SERVICES MAY SEEK A
- 24 ZONING VARIANCE FROM SUSQUEHANNA TOWNSHIP DURING THE CONDUCT OF
- 25 THE SURVEY.
- 26 (G) RELOCATION.--THE DEPARTMENT OF GENERAL SERVICES SHALL
- 27 PREPARE OTHER FACILITIES TO RECEIVE COMMONWEALTH EMPLOYEES WHO
- 28 WILL BE DISPLACED BY THE SALE OF THE PROPERTY.
- 29 (H) CONVEYANCE.--FOLLOWING THE RECEIPT OF THE PLAN UNDER
- 30 SUBSECTION (E), THE GENERAL ASSEMBLY SHALL CONVEY THE PROPERTY

- (IV) PUBLIC ACCESS TO THE DELAWARE RIVER WHICH IS CONSISTENT WITH THE WATERFRONT SETBACK REQUIREMENTS SET FORTH IN SECTION 14-216(6)(G) OF THE PHILADELPHIA CODE (ENACTED INTO LAW BY AN ORDINANCE ENACTING BILL NO. 050465, PASSED BY THE CITY COUNCIL ON JUNE 16, 2005, AND SIGNED BY THE MAYOR ON JULY 8, 2005).
- (2) SHOULD THE LESSEE, ANY SUBLESSEE OR ANY OF THEIR RESPECTIVE SUCCESSORS OR ASSIGNS WISH TO MODIFY THE PUBLIC ACCESS AND PARKING REQUIRED BY THIS SECTION, THE LESSEE, SUBLESSEE OR THE RESPECTIVE SUCCESSOR OR ASSIGN MUST OBTAIN THE PRIOR WRITTEN APPROVAL OF THE DEPARTMENT OF ENVIRONMENTAL PROTECTION AND THE DEPARTMENT OF GENERAL SERVICES, WHICH APPROVAL SHALL NOT BE UNREASONABLY WITHHELD. THE PUBLIC ACCESS AND PARKING SHALL BE COMPLETED AND OPEN TO THE PUBLIC NO LATER THAN THE DATE THE FIRST TENANT OR RESIDENT OCCUPIES EITHER THE LEASEHOLD OR THE LAND ADJACENT TO THE LEASEHOLD.
- 20 (G) LAND USE RESTRICTION.--ALL LEASES AUTHORIZED OR REFERRED
