A RESOLUTION

1 Recognizing and honoring Chief Special Warfare Operator Brett D. ◀
2 Shadle, formerly of Elizabethville, Dauphin County, who died ◀
3 during a military training exercise on March 28, 2013, in
4 Arizona at 31 years of age, and expressing the condolences of
5 the House of Representatives.

6 WHEREAS, The House of Representatives respectfully

7 acknowledges that Chief Shadle attained his long-held goals of ◀

8 following his brother into Navy service and becoming a SEAL and

9 notes that he fully possessed the energies and discipline

10 required for the rigors of that service; and

11 WHEREAS, Chief Shadle enlisted following his 2000 graduation ◀

12 from Upper Dauphin High School, where he had distinguished

1 himself on the basketball and soccer teams; and

2 WHEREAS, Chief Shadle earned two Bronze Star Medals with ◀
3 Valor and several service ribbons during multiple deployments in
4 Iraq and Afghanistan; and

5 WHEREAS, Joint Expeditionary Base Little Creek, Virginia
6 Beach, conducted a memorial service for Chief Shadle on April 4, ◀
7 2013; and

8 WHEREAS, Flags were lowered to half-staff in this
9 Commonwealth, the State of Arizona, the Commonwealth of Virginia
10 and the City of Virginia Beach to honor fallen Chief Shadle; and ◀

11 WHEREAS, Chief Shadle was interred with full military honors ◀
12 at Arlington National Cemetery on May 3, 2013; and

13 WHEREAS, The House of Representatives commends Chief Shadle's ◀
14 defense of our freedoms as a highly decorated member of the Navy ◀
15 SEALs; and

16 WHEREAS, The House of Representatives extends deepest
17 sympathies to Chief Shadle's parents, his brother, his wife and ◀
18 his children; therefore be it ◀

19 RESOLVED, That the House of Representatives recognize and
20 honor Chief Special Warfare Operator (SEAL) Brett D. Shadle, ◀
21 formerly of Elizabethville, Dauphin County, who died during a
22 military training exercise on March 28, 2013, in Arizona at 31
